## COMMENT DEADLINES SET FOR *FURTHER NOTICE OF PROPOSED RULEMAKING* SEEKING COMMENT ON EXPANDED ELECTRONIC DELIVERY OF CERTAIN MVPD NOTICES

MB Docket Nos. 17-105 and 17-317

**Comment Date: April 8, 2019**  
**Reply Comment Date: April 22, 2019**

On November 16, 2018, the Commission released a *Report and Order and Further Notice of Proposed Rulemaking (FNPRM)* in MB Docket Nos. 17-105 and 17-317 that sought comment on whether we should permit certain MVPD notices to be delivered electronically to subscribers via means other than verified e-mail.<sup>1</sup> The Commission set deadlines for filing comments and reply comments at 30 and 45 days, respectively, after publication of the *FNPRM* in the Federal Register.<sup>2</sup> A summary of the *FNPRM* was published in the Federal Register on March 7, 2019.<sup>3</sup> Thus, comments must be submitted no later than April 8, 2019. Reply comments must be submitted no later than April 22, 2019. Commenters must follow the filing instructions provided in paragraph 36 of the *FNPRM*.<sup>4</sup> The *FNPRM* is also available on the Commission's website.<sup>5</sup>
