DOMESTIC SECTION 214 APPLICATION GRANTED FOR THE TRANSFER OF CONTROL OF TELEGUAM HOLDINGS, LLC TO FORAGER HOLDINGS CORP.

WC Docket No. 17-46

By this Public Notice, the Wireline Competition Bureau (Bureau) grants the application filed by TeleGuam Holdings, LLC (TeleGuam), AP TeleGuam Holdings, Inc. (AP TG), and Forager Holdings Corp. (Forager) (together, Applicants), pursuant to Section 214 of the Communications Act of 1934, as amended, and Sections 63.03 and 63.04 of the Commission's rules, requesting consent to transfer control of TeleGuam to Forager.¹

On February 28, 2017, the Bureau released a Public Notice requesting comment on the Application.² On May 11, 2017, the Department of Homeland Security, with the concurrence of the U.S. Department of Justice and the U.S. Department of Defense (collectively, the Executive Branch Agencies), filed a letter requesting that the Commission defer action on this proceeding while they completed their review of any national security, law enforcement, and public safety issues.³ We deferred action in response to the Executive Branch Agencies' request. On June 22, 2017, the Executive Branch Agencies notified the Bureau that they withdraw their request to defer action and stated that they have no objection to the Application.⁴

The Bureau finds, upon consideration of the record, that grant of the Application will serve the public interest, convenience, and necessity.⁵ Pursuant to Section 1.103 of the Commission's rules, 47
