**WIRELINE COMPETITION BUREAU ANNOUNCES UPCOMING TRANSITION  
OUTREACH EDUCATION PLAN WEBCAST AND MECHANIZED USER FOCUSED  
CONTINGENCY ROLLBACK FOLLOW-UP SESSION**

By this Public Notice, the Wireline Competition Bureau (WCB) announces the date and time of the 21st Local Number Portability Administrator (LNPA) Transition Outreach and Education Plan (TOEP) webcast, and a follow-up session for contingency rollback planning focused on mechanized users. The WCB hereby also provides links to archived materials from the July and August 2017 contingency rollback sessions and other LNPA transition reference documents.

First, the TOEP webcast is scheduled for **October 11, 2017 at 3:00 pm EDT**, and will be hosted by PriceWaterhouseCoopers, LLP, the Transition Oversight Manager (TOM) for the LNPA transition. These webcasts are one of the channels used to communicate with the public in accordance with the TOEP as described in the Transition Oversight Plan.<sup>1</sup>

The TOM has conducted a TOEP webcast nearly every month, starting on December 9, 2015.<sup>2</sup> These webcasts are designed to keep interested parties informed about the upcoming LNPA transition. The objectives for the TOEP webcasts are three-fold:

- To provide transparent communications regarding the LNPA Transition;
- To serve as an open forum to gather and understand needs and concerns; and,
- To incorporate feedback to improve future communications.

Second, the mechanized user follow-up session on contingency rollback planning is scheduled for **October 3, 2017 at 3:30 pm EDT**, and will be hosted by the TOM. This session is a mechanized user focused follow-up to the contingency rollback industry session held on August 16, 2017. **Ex Parte Presentations.** This proceeding shall continue to be treated as a “permit-but-disclose” proceeding in accordance with the Commission’s *ex parte* rules, and other relevant WCB guidance.<sup>3</sup> To the extent that parties make presentations that are not subject to the modified procedures, the Commission’s filing requirements for “permit-but-disclose” proceedings under Section 1.1206 of the Commission’s rules apply.

Persons making *ex parte* presentations must file a copy of any written presentation or a memorandum summarizing any oral presentation within two business days after the presentation (unless a different deadline applicable to the Sunshine period applies). Persons making oral *ex parte* presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the *ex parte* presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter’s written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum. Documents shown or given to Commission staff during *ex parte* meetings are deemed to be written *ex parte* presentations and must be filed consistent with rule 1.1206(b). In proceedings governed by rule 1.49(f) or for which the Commission has made available a method of electronic filing, written *ex parte* presentations and memoranda summarizing oral *ex parte* presentations, and all attachments thereto, must be filed through the electronic comment filing system available for that proceeding, and must be filed in their native format (e.g., .doc, .xml, .ppt, searchable.pdf). Participants in this proceeding should familiarize themselves with the Commission’s *ex parte* rules.
