Annual Certification of Support for Eligible Telecommunications Carriers Pursuant to 47 C.F.R. §54.314

Dear Ms. Dortch and Ms. Majcher:

Pursuant to the requirements of 47 C.F.R. § 54.314, and the authority delegated to me by the Public Service Commission of Wisconsin (PSCW), the PSCW hereby certifies to the Federal Communications Commission (FCC) and the Universal Service Administrative Company that the telecommunications carriers included in this letter are eligible to receive federal support (including high-cost support where applicable) for the program years cited below. This certification is based on review of the copies of the FCC Forms 481 or 690 submitted to the PSCW.

The PSCW certifies that, for the carriers listed on the attached table, all federal high-cost support provided to such carriers within Wisconsin was used in the preceding calendar year (2015) and will be used in the coming calendar year (2017) only for the provision, maintenance, and upgrading of facilities and services for which the support is intended.¹

The PSCW also requested sworn affidavits from each Eligible Telecommunications Carrier stating that they certify they are in compliance with state Lifeline requirements. These requirements include use of queries of state databases to determine eligibility information through a web interface as the first and primary basis for confirmation of eligibility. Each of the listed carriers provided such certification and are eligible for continued compensation from the federal low-income program.
