Dear Secretary Dortch:

Network Billing Systems LLC dba Fusion dba Solex ("NBS") and BCN Telecom, Inc. ("BCN") (collectively, the "Companies") hereby request withdrawal of the Companies' May 26, 2017 *Joint Section 214 Application Filed for the Assignment of Certain Assets of BCN Telecom Inc. to Network Billing Systems* and August 22, 2017 *Joint Application for Authority to Complete an Assignment of Assets Between Authorized International 214 Carriers* ("Applications") in the above referenced matters, currently pending before the Commission.

NBS' and BCN's plans for the transaction have undergone certain changes. The Companies are withdrawing their Applications to address these changes and expect to refile the Applications at a later date once all issues have been resolved. There will be no impact on subscribers who will continue to be served by BCN until the resubmitted Applications are approved. The Companies acknowledge that Application resubmission will entail an entirely new application process.


