Verizon Communications Inc. (“Verizon”) submits a CD containing a privilege log to be associated with its September 30, 2016 production of documents responsive to the Wireline Competition Bureau’s Information and Data Request (“Information Request”) dated June 22, 2016, in connection with the above-referenced transaction.
