

PETITION FOR RULE MAKING

Danjon, Inc. ("Danjon"), by its attorney and pursuant to Section 1.420 of the Commission's Rules, hereby requests the Commission to institute a rule making proceeding to amend Section 73.202(b) of its Rules to allot Channel 284A to Prineville, Oregon as that community's first local service. In support thereof, the following is respectfully shown:

1. The proposed allotment can be made by the Commission in complete compliance with Section 73.207 of the Commission's Rules. As indicated by the attached channel spacing study, the proposal will not conflict with any other existing broadcast stations' operations and requires no other changes to the Table of Allotments at the reference coordinates shown.

2. The allocation of Channel 284A, a 6 kW allotment, to Prineville, Oregon would be that community's first local service. Prineville is listed in the 1980 U.S. Census, has a post office, a zip code of its own (97754), and is shown in the Rand-McNally Road Atlas. It has a population of 5,276. Further, Prineville is located in Crook County which does not have any local radio service. The proposed allotment would provide an important new

broadcast service to the population of Prineville and its immediate environs and is therefore in the public interest.

3. The proponent intends to apply for a construction permit for Channel 284A at Prineville, Oregon upon amendment by the Commission of its Table of Allotments and further intends to construct such facilities immediately following the Commission grant of the construction permit to it. It is therefore submitted that the public would be served by modification of the FM Table of Allotments as follows:




