Dear Mr. Palmer,

Interstate Telecommunications Cooperative, Inc. ("Interstate" or "Cooperative") is an incumbent local exchange carrier which owns two study areas in the state of South Dakota – Study Area Codes 391654 and 391679. Both study areas operate under the same Cooperative entity, and are authorized to receive Alternative Connect America Cost Model II support.

Interstate hereby notifies the Federal Communications Commission ("FCC" or "Commission") that effective January 1, 2020, the Company will consolidate the foregoing study areas with 391654 being the surviving study area. Pursuant to FCC precedent, no prior approval is required when commonly-owned existing study areas in the same state are consolidated.¹
