Dear Ms. Dortch:

Pursuant to Section 51.332 of the Commission's rules, CenturyLink hereby submits for Qwest Corporation the attached Public Notice No. 790 for copper retirements in Arizona, Colorado, Idaho, Iowa, Nebraska, New Mexico, North Dakota, South Dakota and Washington.²

These retirements will have no impact on the services provided to the retail customers served by the copper facilities that will be retired.

Pursuant to the FCC's Order of November 26, 2014,³ one copy (in PDF format) of this material is attached as an electronic submission. CenturyLink has provided each entity within the


