Pursuant to the requirements of 47 C.F.R. § 54.314, the New Mexico Public Regulation Commission (the "Commission") hereby certifies to the Federal Communications Commission ("FCC") and the Universal Service Administrative Company ("USAC") that the telecommunications carriers included in this letter are eligible to receive federal high-cost support for the program years cited. Attached to this letter is the printout from the USAC website showing the certification entries our agency made today.


