LOCAL PUBLIC NOTICE

Notice is hereby given that the application for a new FM Broadcast Station to be located in Baldwin, FL with operation on channel 289A filed by JEM Production, Limited Partnership was designated for hearing by the federal communications commission. The FCC released the hearing designation order on February 14, 1991. The hearing will be held in Washington, D.C. to be convened on May 24, 1991 commencing at 10:00 A.M. The names of the applicants designated for hearing are: White Broadcasting Partnership, Peaches Broadcasting, Ltd., Sage Broadcasting Corporation of Jupiter, Florida, First Coast Broadcasting Company, Douglas Johnson, Northeast Florida Broadcasting Corp., and JEM Production, Limited Partnership C/O Joyce Moran. The issues listed in the FCC's order are:

1. To determine whether there is a reasonable possibility that the tower height and location proposed by White, Peaches, Sage, Coast, Johnson and Northeast would constitute a hazard to air navigation.
2. To determine which of the proposals would, on a comparative basis, best serve the public interest.
3. To determine in light of the evidence adduced pursuant to the specified issues, which of the applications should be granted, if any. A copy of the application and related material are on file for public notice at Baldwin City Hall, Baldwin, Florida.
