Allstream initially intends to provide service in Arizona, California, Idaho, Nevada, Oregon, Utah and Washington.

III. Percent of Foreign Ownership

Zayo Group, LLC owns 100% of Allstream Business US, LLC which owns 100% of Electric Lightwave, LLC. The parent to Zayo Group is Zayo Group Holdings, Inc. (“Zayo”), a publicly traded company. Proxy statements filed by the company with the SEC show beneficial ownership of the company. Zayo has only one owner, Dodge & Cox with 10% or greater ownership (10.0% as of March 31, 2018).¹ Dodge & Cox is a operates investment funds that are offered for sale only in the United States.²
