**AMENDED SECTION 63.71 APPLICATION**

BroadSoft Adaption, Inc. (“BroadSoft Adaption”) through its undersigned counsel and pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and Section 63.71 of the Commission’s rules, 47 C.F.R. § 63.71, hereby amends its September 17, 2018 application to discontinue the provision of voice services made available to customers of its BroadSoft Business suite of software services.

As explained in the September 17, 2018 application, BroadSoft Adaption attempted to provide written notice of the planned discontinuance to all affected customers by email. Shortly after filing the application, however, BroadSoft Adaption learned that delivery of the notice had failed with respect to a small number of affected customers. For all customers that experienced a delivery exception, BroadSoft Adaption was able to verify email address information and successfully deliver the written notice required by the Commission’s rules. Thus, written notice for all affected customers was provided prior to the date of this filing.

As required by Section 63.71(a) and (b) of the Commission’s rules, BroadSoft Adaption provides the following information in support of its application as amended:

1. **Name and address of carrier**

BroadSoft Adaption, Inc.

2. **Date of planned service discontinuance**

BroadSoft Adaption plans to no longer offer voice services to new BroadSoft Business customers, and to discontinue voice services to existing non-term BroadSoft Business customers, on November 14, 2018 subject to regulatory approval. For existing BroadSoft Business customers on term agreements that provide for the use of voice services, BroadSoft Adaption plans to discontinue voice services on November 14, 2018 or the expiration of the customer's term agreement, whichever is later. Existing term agreements will not be renewed or extended.

3. **Points of geographic areas of service affected**

BroadSoft Adaption proposes to discontinue voice services made available to BroadSoft Business customers in all U.S. states and the District of Columbia.

4. **Brief description of the type of service affected**

BroadSoft Business is a suite of cloud-based communications, collaboration, and contact center software services sold to enterprise customers. For some BroadSoft Business customers, BroadSoft Adaption provides voice services that allow end-users to make and receive VoIP calls over an existing broadband connection (which is not provided by BroadSoft Adaption) using IP-compatible equipment. These voice services are being discontinued.

5. **Brief description of the dates and methods of notice to all affected customers**

BroadSoft Adaption provided written notice to all affected customers on or

before October 2, 2018. A copy of the customer notice is attached as Exhibit A.

BroadSoft Adaption attempted to provide written notice to all affected customers—and successfully provided written notice to most affected customers—on or before September 14, 2018. That written notice was delivered by email, which is how BroadSoft Adaption generally delivers notices regarding its BroadSoft Business services. BroadSoft Adaption chose electronic delivery because it determined that it would inform its customers most effectively by using an established channel of communication.

As discussed above, BroadSoft Adaption experienced delivery issues with respect to a small number of affected customers that it attempted to notify in September. After verifying email address information, BroadSoft Adaption successfully delivered written notice to all of these customers via email on or before October 2, 2018.

6. **Whether the carrier is considered dominant or non-dominant with respect to the service to be discontinued**

BroadSoft Adaption is considered non-dominant with respect to the service to be discontinued.

7. **Other information**

BroadSoft Adaption's discontinuance of voice services made available to BroadSoft Business customers will not adversely affect the public convenience and necessity, and the public will not be harmed by the discontinuance. Customers have been given notice that affords them ample opportunity to acquire reasonable substitute service which is readily available from other providers.

Pursuant to Section 63.71 of the Commission's rules, BroadSoft Adaption is

submitting a copy of this application via U.S. Mail to the public utility commissions and to the governors of all U.S. states and the District of Columbia, and to the Special Assistant for Telecommunications for the Secretary of Defense, concurrent with the filing of this application.

### **CONCLUSION**

BroadSoft Adaption respectfully requests that the Commission approve its Section 63.71 application, as amended, to discontinue the provision of voice services made available to its BroadSoft Business customers.

## **Exhibit A: Customer Notice**

BroadSoft Adaption, Inc. is sending this message to key contacts at [CUSTOMER] regarding important changes to your BroadSoft Business service.

This is an important notice about the discontinuance of voice services made available to you as a BroadSoft Business customer.

BroadSoft Adaption, Inc. has provided you with voice services that allow users under your subscription to place and receive VoIP calls to and from most telephone numbers. However, as we have previously notified you, BroadSoft Adaption intends to no longer offer, and to discontinue, these voice services in all U.S. states and the District of Columbia on November 14, 2018. If you are on a term agreement that provides for the use of these voice services, BroadSoft Adaption will continue to provide voice services until November 14, 2018 or the expiration of your term agreement, whichever is later. Existing term agreements for the provision of voice services will not be renewed or extended.

The Federal Communications Commission\* ("FCC") will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the Commission's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the § 63.71 Application of BroadSoft Adaption, Inc. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.

We regret any inconvenience this may cause, and hope that you will continue to take advantage of other BroadSoft services in the future.
