COMMENTS IN SUPPORT OF NOTICE OF PROPOSED RULE MAKING

Lu Ann Uchida Lane hereby files her Comments in support of the Commission's Notice of Proposed Rule Making ("NPRM"), DA 92-105 (released February 10, 1992), in the above-captioned proceeding.

1. The Commission issued its NPRM in response to Mrs. Lane's Petition for Rule Making ("Petition"), which requested the initiation of a rule making proceeding looking toward the allotment of FM Channel 240A to Poipu, Hawaii as that community's first local broadcast service.

2. The Commission has obviously found merit in Mrs. Lane's Petition, for the NPRM has proposed to amend the FM Table of Allotments by allotting Channel 240A to Poipu. The NPRM set March 30, 1992 as the deadline for Comments in this proceeding, and required Mrs. Lane to file a Statement of Continuing Interest in applying for the proposed Poipu facility by that date. Mrs. Lane tenders these Comments to satisfy that obligation and to

reiterate her request that the Commission allot Channel 240A to the community of Poipu.

3. As the proponent of the Poipu allotment, Mrs. Lane hereby incorporates by reference her Petition. Mrs. Lane also hereby expressly restates her present intention to apply for the new channel if the Commission allots it and, if authorized, to build the new Poipu facility promptly. The public interest will clearly be served by modifying the FM Table of Allotments to include an entry for Poipu.

CONCLUSION

Based on the foregoing, Lu Ann Uchida Lane respectfully urges the Commission to issue a Report and Order, as expeditiously as possible, implementing the proposal set forth in the Notice of Proposed Rule Making in this proceeding.


