Keith Carnahan, President and CEO after being duly sworn, states the following:

1. I have personal knowledge of the facts and information set forth in this Affidavit and I am competent to testify to these facts if called as a witness.
2. I am President and CEO of ML Connect, LLC and Meriwether Lewis Electric Cooperative ("MLEC"). Acting on behalf of MLEC and ML Connect, LLC, I have read the Petition to which this Affidavit is attached. I have knowledge of the facts stated in the Petition and those facts are true to the best of my knowledge and my belief.
3. ML Connect, LLC certifies that it is a common carrier under §§ 214(e)(1) and 214(e)(6) of the Communications Act of 1934, as amended ("Act").
4. ML Connect, LLC commits to provide the services and functionalities required for designation as a high-cost and/or low-income Eligible Telecommunications Carrier ("ETC") in the winning areas of the Census Block Groups identified in Exhibits A1 and A2 to the Petition.
5. ML Connect, LLC certifies that it will meet the Commission's requirements for designation as an ETC under § 214(e)(6) of the Act.
6. I am the corporate officer responsible for certifying ML Connect, LLC's use of federal high-cost support. Petitioner is eligible to be designated as an ETC within the meaning of Section 214(e) of the Act and is eligible to receive universal service support pursuant to Section 254(e) of the Act.
7. Petitioner will use the federal high-cost support funds that it receives only to provide, deploy, upgrade and/or maintain facilities and services for which the support is intended.

8. Petitioner certifies that no party to this petition is subject to denial of federal benefits, including Commission benefits, pursuant to § 5301 of the Anti-Drug Abuse Act of 1988.
