Tenaha Schools, Entity Number 16060897, formally requests a waiver of the deadline for filing Form 471 for Year 2018. Martha Boren, our E-Rate manager on our campus, missed the deadline for filing this Form 471 because she was of the opinion that our school had a three year contract with our provider, ESC 7 for internet services. This contract was duly executed by all parties on March 31, 2017 and was for the term of July 1, 2017 through June 30, 2020.

Upon discovery of her mistake, she tried to file a Form 471 Application Number 181043453 outside of the filing window; however, due to its untimeliness she was not able to complete this process.

Also, Mrs. Boren has been ill since before Thanksgiving and has only been able to work sporadically and is now on leave to have open heart surgery. My name is Terry Bowlin, Chief Operations Officer of Tenaha Independent School District and I have been charged by our superintendent, Scott Tyner begin the process of requesting a waiver as well as to make sure our E-Rate is properly filed for 2019.

Tenaha Schools realizes that the time for filing the Form 471 for 2018 has well passed. But we respectfully ask the FCC to allow a waiver on behalf of our school

Tenaha Independent School District is a small rural school district with 91% economically disadvantaged rate. We depend on these funds to operate our internet system for our students. The lack of these funds has and will continue to make an extreme financial hardship on the district. If the funds allocated for Tenaha ISD are still available, we request that Tenaha Schools be allowed to immediately file Form 471 for Year 2018 so that a Form 486 can be filed, and funding restored for this service.

Please do not let the mistake of one person affect the entire school district and our students.
