The State of Iowa, Iowa Telecommunications & Technology Commission (ITTC) cannot certify that it can keep CPNI confidential under current Iowa statutes. The ITTC does believe it is compliant with the intent of 47 C.F.R. § 64.2009(e).

The customers of the ITTC are state agencies, educational facilities, health care facilities, etc. The ITTC is currently limited in its scope of customers by Iowa Code under § 8D.3, § 8D.11, and § 8D.13, and is not permitted to provide telecommunications services to individuals.

Additionally, the ITTC is covered by Iowa Code under Chapter 22, which governs Examination of Public Records, also known as open records. The vast majority of the information the ITTC retains concerning customers relates to the entity, not to individuals. Information on individuals is limited to two areas. The first group is state employees, and only to the extent that the person is a state employee and has a certain phone number, which the state has opted to publish to the public at large. The second group is the contacts within the customer agencies and entities with which the ITTC staff work to provide services as requested, and all information associated with those individuals would be their work contact information.

The ITTC, as an independent agency of the State of Iowa, does not sell, license, or provide any contact information to outside sources, except as covered under an open records request filed under Iowa Code Chapter 22. The majority of the customers are also covered under Iowa Code Chapter 22, so it is reasonable to expect they are familiar with the law.

When the ITTC receives an open records request, the communications staff ensures the information does not fall into the areas excluded by Iowa Code Chapter 22.7, Confidential Records.
