Re: Appeal Submitted on January 17, 2018

This is a supplemental paper to clarify the M/C error made on the FY 2017 Application Number 171004128, FRN 1799006928 for the Hawlemont Regional School District BEN 2014012.

Please refer to the Crocker bill and the cost calculation page from the original Form 471 application for verification.

When calculating the figures for the application and taking out the ineligible items, I used the subtotal figure from the bill supplied, omitting the \$70.00 Crocker Broadband Voice charge by mistake. The application requires us break down the price by line. \$10.19 per line x 26 lines = \$264.94 – the original incorrect amount applied for.

On the bill, the eligible charges are \$70.00+\$49.90+\$214.80 = \$334.70. When applying the originally omitted broadband voice charge back to the subtotal, the per line figure should be \$12.87 x 26 lines = **\$334.62** – this is the amount I am requesting to be corrected to.
