PETITION FOR SPECIAL RELIEF

Harrison County, Texas, pursuant to Section 338 of the Communications Act and Sections 76.7, 76.59 and 76.66 of the Commission's rules, hereby requests (hereinafter, the "Petition") that the television market of KLTN, Channel 7, ABC, Tyler/Longview, Texas, referred to as the "Station" be modified to include Harrison County (the "County") in northeast Texas with respect to satellite TV provider DISH Network ("DISH") and satellite TV provider DIRECTV ("DIRECTV"). The County has long been assigned by Nielsen to the Shreveport, Louisiana designated market area ("DMA"). As such, the County has been "orphaned" by Nielsen due to its assignment to an out-of-state DMA and has been deprived of the ability to receive from a satellite carrier its preferred in-state television broadcast stations. Consumers in the County have been unable to receive from a satellite carrier important news from their own local cities, nor emergency information quickly and accurately in the County. Further, residents have had far fewer opportunities to view televised news, sports, weather, politics and other things of public interest within and throughout their own state.

The STELA Reauthorization Act of 2014 ("STELAR") empowered the Federal Communications Commission ("FCC or "Commission") to modify a television broadcast

station's local market when it would, among other things, "address satellite subscribers' inability to receive in-state programming in certain areas." This Petition thus falls within Section 338's market modification provision, which allows the Commission to "include additional communities within [a station']...to better effectuate the purposes of this section."

For the reasons explained below, the County requests that the Commission modify the Stations' local markets, as defined in 17 U.S.C. § 122(j), to include the County with respect to carriage by DISH and DIRECTV. The County is governed by the constitutionally established Harrison County Commissioner's Court and all actions requested herein are approved by the governing body by formal agenda and vote of the members. The presiding officers of Texas County Commissioner's Courts are the Constitutional County Judges, and therefore the duly elected County Judge signs this petition below as authorized by the governing body. Counties are exempted from the filing fee for said Petition.

I. THIS PETITION SATISFIES THE STATUTORY FACTORS

As required by STELAR, the Commission determines whether to grant a market modification based on consideration of five statutory factors. These factors reflect the four factors previously applicable to market modifications in the cable context, plus an additional factor to assess "whether modifying the local market of the television station would promote consumers' access to television broadcast station signals that originate in their State of residence." The five factors are:

1. Whether the station or other stations located in the same area have been historically carried on: (a) the cable system or systems within that community; and (b) the satellite carrier or carriers serving that community;
2. Whether the television station provides coverage or other local service to that community;

3. Whether modifying the local market of the television station would promote consumers' access to television broadcast station signals that originate in their state of residence;
4. Whether any other television station that is eligible to be carried by a satellite carrier in the community in fulfillment of the requirements provides news coverage of issues of concern to the community or provides carriage or coverage of sporting and other events of interest to the community; and
5. Evidence of viewing patterns in households that subscribe and do not subscribe to the services offered by multichannel video programming distributors within the areas served by the multichannel video programming distributors in the community.

A. This Petition Satisfies the Third and Most Important Factor By Bringing an In-State Local Broadcast Stations to Consumers Who Historically Have Been Unable to Receive It From a Satellite Carrier

Where, as here, the purpose of the market modification is to bring a previously unavailable (via satellite carrier) in-state local broadcast stations to a community, the third-factor should carry significant weight in the Commission's analysis. Today, because the County is assigned to the Shreveport, Louisiana DMA, local broadcast content available by satellite is oriented to the interests of a different state. The Station is licensed in the Tyler-Longview, Texas DMA, which is in the same state as the County. As the Harrison County Commissioners have previously explained, "This is about emergency news, weather and local interest stories." The process will allow the county to access news, politics, sports, emergency information and other television programming from its own area. (See Exhibit 1, Marshall News Messenger Online Article February 15, 2017. (12 comments from residents online)) One reader, Mrs. Melson, comments "Thank goodness. It would be nice to see news from our local area rather than what is going on in another state! If it is a marketing issue, people in Western Harrison County are more likely to

shop in Longview less than 10 miles away than Shreveport, 60 miles away.”(See also Comments to include one from Mr. Charles Hadlock, Producer and Reporter at NBC Network)

This Petition therefore satisfies the third factor by delivering in-state local broadcast stations from Tyler-Longview, Texas, over DISH’S and DIRECTV’S satellite TV service to consumers in the County who have previously been unable to receive it from DISH and DIRECTV. As explained, this third in-state factor should receive enhanced weight when the Commission considers market modification petitions.

The most compelling case to satisfy the third factor comes from the City of Longview, Texas. Longview enjoys the benefits of recent growth and now sees population expansion in city limits that extend into Harrison County, Texas. The Harrison County, Texas duly appointed Elections Administrator Mike McMurry reports as of January 2, 2018, his records reflect that there are one thousand three hundred (1,300) registered voters that live in Harrison County and are also within the City of Longview, Texas. Most city offices and city residents are located across the county line in adjoining Gregg County, Texas. Therefore, the city limits of Longview, Texas, extends out of Gregg County into Harrison County, Texas. (See Exhibit 2, Map of Gregg and Harrison Counties including Longview, Texas.) The Station covers news regarding Longview, Texas. Gregg County, Texas lies in the Tyler-Longview DMA. In the current situation, Harrison County residents, who are also within the city limit of Longview, Texas, are not able to view the news covering Longview, Texas, due to Harrison County’s orphaned status. (See Exhibit 3, Letter of Support From Mayor of Longview, Texas.) Specific stories viewed by Longview residents in Gregg County but **NOT** by Longview residents across the line in Harrison County are included in Exhibit 4.

Grant of the this Petition would enable DISH and DIRECTV subscribers in the city of Longview to receive the Station, which offers local-oriented weather, news, sports, political coverage, and advertising, among other things, through their satellite TV package. As our exhibits and letters portray, the additional coverage requested is also a matter of public safety of our constituents. One resident writes “...this is a safety manner (sic), we would get storm information from the west and earlier when storms are in our area...” (See Exhibit 5, Letter from Turner. Exhibit 6, Letter from Copeland. Exhibit 7, Letter from Fulbright.)

B. The Remaining Factors Support This Petition

The first, second, and fifth factors all relate to historical or current opportunity to view the State in the County (the first and second factors), and whether the residents of the County have availed themselves of such opportunities (the fifth factor). Since the purpose of STELAR was to facilitate access to in-state broadcast programming, neither a lack of historical carriage or coverage, nor a commensurate lack of historical viewing patterns for the Station, should weigh against the requested market modification. Because the County has long been assigned by Nielsen to an out-of-state DMA, STELAR’s market modification provision marks the first opportunity in many years for the County to receive the Station’s signal over satellite. Given this lack of carriage, residents of the County have had little opportunity to develop any viewing patterns for the Station. It is precisely this lack of opportunity to view, via satellite TV, an in-state network-affiliated station that this Petition intends to remedy. Regarding the fourth factor, the County is familiar with Shreveport broadcast stations that should deliver local content, but is unaware of another in-state local broadcast station carried by a satellite provider in the County that offers Longview and Texas-oriented news coverage of issues of concern to the degree expected by residents of the County.

II. EVIDENTIARY SHOWING

The County submits evidence as explained below responsive to the evidentiary requirements in the Commission's rules.

- With respect to Factor 1, Commission rules require that market modification petitions include "[c]able system or satellite carrier channel line-up cards or other exhibits establishing historic carriage [of a given station], such as television guide listings." The evidence submitted is a basic lineup card of coverage. Exhibit 8
- With respect to Factor 2, attached as Exhibit 9 is a map illustrating the location of the County and indicating the Stations' coverage area based on over-the-air signal strength.
- With respect to Factor 3, the Petition includes many comments and letters indicating consumer public support for market modification.
- Although market modifications generally require information on "shopping and labor patterns in the local market," such data should not impact any decision about whether or not residents of the County should be able to receive Texas based local broadcast stations by satellite. Nonetheless, residents of the County will benefit from being able to receive an in-state local broadcast station from Tyler/Longview because the station provides news, state political coverage, sports and other information that is important to them as Texas residents. Therefore, to the extent necessary, we respectfully request a waiver of this item as such information is not available to the County and offers little to no value to the Commission in assessing the merits of this petition. This petition does include evidence of stories run in the Tyler/ Longview DMA affecting Longview residents that were not run in the Shreveport DMA, depriving Harrison County residents of Longview, Texas the benefit of local broadcasting.
- With respect to Factor 4, the County provides a listing of Texas Sporting Teams that are preempted in the County for coverage of Louisiana teams. (Exhibit 10)
- With respect to Factor 5, Commission rules require that market modification petitions include "[p]ublished audience data for the relevant station showing its average all day audience... for both multichannel video programming distributor (MVPD) and non-MVPD households[.]" As discussed above, given the lack of available historical carriage of the Stations in the County, to the extent necessary, we respectfully request a waiver of this item.

III. TECHNICAL AND ECONOMIC FEASIBILITY

On September 12, 2016 the County sent to DISH a pre-filing coordination letter pursuant to 47 C.F.R. § 76.59 (e) of the Commission's rules (Exhibit 11) DISH responded on December 19, 2016 ("DISH Response") (Exhibit 12) opined in a boilerplate letter that based on DISH's current knowledge and satellite coverage capabilities, factors exist that render the provision of the Station in the County to be infeasible pursuant to 47 C.F.R. § 76.59(e).

On September 12, 2016, the County sent to DIRECTV a pre-filing coordination letter pursuant to 47 C.F.R. § 76.59(e) of the Commission's rules (Exhibit 13.) DIRECTV responded by letter on October 4, 2016 and follow-up letter dated January 19, 2017("DIRECTV Response") (Exhibit 14) and confirmed that based on DIRECTV's current knowledge and satellite coverage capabilities, DIRECTV can provide service within the County with its SD spot beam and HD service to all zip codes associated with the request because reception of the signal does meet the minimum performance thresholds for DIRECTV's service. No factors were identified that rendered the provision of the Stations in the County to be "economically infeasible" or "technically infeasible" pursuant to 47 CF.R. § 76.59(e).

Carriage of Texas television in Harrison County, Texas is an issue of utmost importance to the citizens of our community. In that regard, attached as Exhibit 15 are more public comments recently submitted to the online newspaper site encouraging the Harrison County Commissioners, the governing body of the county, to file this petition. One comments"...I don't care what the Governor of Louisiana is doing, I need to know the Texas news." Over the years, countless other constituents have expressed their strong desire for Tyler-Longview television

programming to the Harrison County Commissioners by telephone and personal contact within the community.

Congress authorized STELAR to provide a common sense solution that will benefit our constituents that are disenfranchised by living in the “orphaned” Harrison County, Texas and other counties across the nation similarly situated. Our U. S. Senator John Cornyn concurs in his letter of support (Exhibit 16.) Likewise, Congressman Louie Gohmert is very familiar with his First District of Texas and the inability of his Harrison County, Texas constituents to receive in-state broadcasts. (Exhibit 17)


Finally, attached as Exhibit 18, a letter of support from Texas State Senator Bryan Hughes showing support for the petition in that “...people of Harrison County have strong ties to their in-state neighboring communities to the west...” Senator Hughes is elected by constituents in Senate District One which includes all counties near the Louisiana border in the Northeast Texas region including Harrison, Gregg and Smith Counties in which lie the cities of Marshall, Longview and Tyler respectively.

IV. CONCLUSION

For the foregoing reasons, the County urges the Commission to expeditiously grant its Petition.

Harrison County seeks East Texas TV station access

The Harrison County Commissioners Court approved on Monday to proceed with the filing of a market modification request to the Federal Communications Commission to make Tyler and Longview news stations accessible to Harrison County residents.

The court also approved to spend up to \$5,000 to hire a consulting firm to assist the county with the application process, if needed.

"This is a relevant public interest item if there ever was one," said Harrison County Judge Hugh Taylor.

He said, in fact, a constituent in Hallsville had just spoken with him that morning about the great interest. Pct. 4 Commissioner Jay Ebarb, who represents the Harleton area on the west side of the county, has also been flooded with calls from constituents who are thrilled with the idea.

"We're not to the finish line, but we hope to get the process moving down the road a little bit," Taylor said.


In September, the commissioners court approved to ask satellite providers to initiate a feasibility study to allow the county to gain access to more East Texas news channels west of the county. The action became a possibility as a result of the FCC's new satellite market modification rules.

"With the help of the station vice president for KLTV (in Tyler), we finally got our responses from the two satellite providers that serve our constituents," Taylor said.

While Dish Network advised that it would be both "technically infeasible" and "economically infeasible" for it to provide the Tyler-Longview service to the county, Direct TV confirmed that its company could.

"Dish said no, but Direct TV said yes, and in their response they actually affirmed that they could provide service for KFXK, KLTV, KYTK and KETK in our market for the benefit of our constituents," Taylor said. "So the Direct TV response was very positive."

The judge said the process is a tedious one, however, which is why he asked the court to approve up to \$5,000 to hire a consulting firm to assist.



"There's a lot of data that has to be compiled (for) these STELAR (Satellite Television Extension and Localism Act Reauthorization) applications and everyone has to be onboard, so I thought I would ask the court to approve to proceed with the filing of the application and set aside some cash in case we have to hire a firm to help us," he said.

"I don't know how long the petitions are considered once we finally accumulate the data necessary to file the appropriate market modification request," he added. But "I hope we can deliver in the future."

He noted that ultimately, local governments, including counties, can request cable operators to offer the same type of modification.

"It's a great deal of interest and I think it'd deliver a great deal of service (regarding) emergency planning for weather," Judge Taylor said. "I think we'd like the opportunity to get both the eastern channels - Texarkana, Shreveport, Bossier - and Longview, Tyler, possibly even Nacogdoches, so this has a huge following.

"I've got direct phone calls here to my office showing interest in going forward," he said. "It's not just about watching the Dallas Cowboys play football, although the Saints are also on at the same time. This is about emergency news, weather and local interest stories."

The process will allow the county to access news, politics, sports, emergency information and other television programming from its own area.

"This is about being part of the western side of this county and hearing about news that is closer to home, hearing news that's closer to their home," said Taylor.

Taylor said a couple of thousand Harrison County residents live in the city of Longview.

"There are several thousand residents in Hallsville and then they are scattered out from Harleton, Noonday (Road), all the way south down Lansing Switch (Road) and Country Club Road and across I-20, out to Quail Lane," he noted. "There are a lot of residents out in the Hallsville, Longview area that have told me they would rather see the Tyler, Longview stations and this may be a means to accomplish that goal.

"It is exciting. It's relevant," he said of the option. "It's an interesting item that I hope our court and our staff can deliver to the constituents."




The City of Longview is proud to have a strong working relationship with Harrison County.

FEASIBILITY CERTIFICATION PURSUANT TO 47 C.F.R § 76.59(e)

1. This Feasibility Certification is issued by DISH Network L.L.C. ("DISH") pursuant to the pre-filing coordination procedures contained in the Federal Communications Commission's ("FCC") Order¹ governing market modifications for satellite carriers under the STELA Reauthorization Act of 2014 ("STELAR").²
2. This Feasibility Certification responds to the letter ("Letter") dated September 12, 2016 from Hugh Taylor, Harrison County Judge, requesting information regarding carriage of local broadcast stations from the Tyler-Longview designated market areas ("DMA") into Harrison County, Texas (the "County").
3. DISH carries the high definition ("HD") Tyler-Longview local broadcast stations ("Tyler-Longview Locals") on spot beams on a satellite located at the 61.5° W.L. orbital slot, and carries the standard definition ("SD") Tyler-Longview Locals on spot beams on a satellite located at the 110° W.L. orbital slot.
4. The ability of an individual DISH subscriber in the County to receive the Tyler-Longview Locals from DISH depends on, among other things, how the subscriber's individual satellite antenna was originally installed and pointed, and whether that subscriber is predicted to have adequate spot beam coverage from the satellite that carries the stations.
5. In general, a DISH customer's satellite antenna, when installed, is pointed so that it can receive satellite signals from specific orbital slots. Receiving service from orbital slots not planned for in the original equipment installation at the subscriber's home typically would require DISH to send a truck and technician to adjust equipment or install different equipment, which would impose a very substantial cost burden on DISH.
6. The relevant spot beams from the two satellites that carry the Tyler-Longview Locals do cover the County. But, DISH subscribers in the County wishing to receive the HD versions of the Tyler-Longview Locals would require a second satellite dish (and a service call to install it) in order to be able to receive service from the 61.5° W.L. orbital slot. This would, among other things, impose a very significant cost burden on DISH.
7. DISH subscribers in the County could likely receive the SD version of the Tyler-Longview Locals with their current satellite dish and set-top boxes ("STBs"). However, providing the Tyler-Longview Locals to the County would create a complex patchwork of different customer scenarios. Among other things, DISH would need to parse its subscribers in the County into different groups depending on whether they receive service

calls and second satellite dishes to enable them to receive service from the 61.5° W.L. orbital slot. DISH would need to make, among other things, operational and billing changes in an attempt to manage these different cases. And attempting to target the provision of the Tyler-Longview Locals to the subset of DISH subscribers in the County who might be able to receive them would cause customer confusion and frustration. For example, one DISH subscriber might be able to receive the HD version of the Tyler-Longview Locals while her neighbor could not. This, in turn, could lead to a poor customer service experience and a burden on DISH if a subscriber requested to have a technician sent to install equipment at DISH's expense in order to receive service from a different orbital location.

8. As a result, DISH has determined that it would be both "technically infeasible" and "economically infeasible" pursuant to 47 C.F.R. § 76.59(e) for DISH to provide the Tyler-Longview Locals to the County.
9. DISH reserves the right to amend this Feasibility Certification at any time due to, among other things, a satellite equipment failure or a different satellite or satellites being brought into service for the area that includes the Counties which has different coverage capabilities than the satellites currently being used.

Thank you for your letter regarding a preliminary evaluation for a potential market modification for Harrison County, TX. While we appreciate your frustrations with the designated market area assignments into your area, we are subject to federal rules and restrictions on our ability to deliver local channels.

We would like to begin work on your request for Harrison County; however, we cannot begin our process until Harrison County indicates specifically which television station(s) DIRECTV should use in its preliminary evaluation of a potential market modification petition. This process requires that the requester follow specific procedures established by the Federal Communications Commission. Once submitted, the request must be reviewed and approved by the FCC, which will determine whether a market modification is warranted based on the Copyright rules and its own criteria for such a change.

Additionally, under the FCC's market modification rules, only broadcasters, satellite carriers and county governments may file a satellite market modification petition. In your letter, you indicate that the Harrison County, TX, Commissioners have unanimously voted to seek a potential market modification for Harrison County. 

Harrison County eyes more TV channels

Harrison County may get access to more news channels, particularly the Longview and Tyler stations, if the county's satellite providers deem it feasible to do so, county commissioners agreed Monday.

The action became a possibility as a result of the FCC's new satellite market modification rules.

"This was brought to our attention by the station manager in Tyler that as of September, last year, FCC rules relaxed whereby each DMA (designated market area) seeks FCC approval by petition to allow outside media outlets to push into the DMA," Harrison County Judge Hugh Taylor said.

"The court is asking, today, to approve a letter from me to those satellite providers that they then undergo their own surveys to determine whether or not Harrison County Texas would be feasible for them to produce a signal into (the area), that is a signal coming out of Longview and Tyler stations, in addition to the Shreveport market," Taylor explained.

"This first step is for the satellite providers to initiate a feasibility study to determine whether or not this market is economically feasible for them to enter with those out-of-market stations," he said.

The judge said the court doesn't have to take any further action on the matter yet.

"It will not cause any action. Until and when they return a letter to us indicating that they do feel like it's technically and economically feasible to do so, then we'll ask the court to approve the petition to the FCC, to relax their rules, modify the rule and authorize their transmission of those stations into this market," Taylor said.

The judge along with Pct. 3 Commissioner James Greer, who represents about 10,000 county residents who live close to Longview on the west side of the county, met with an official from the Tyler station to learn more about the opportunity.

"Mr. Greer and I had a meeting with one of the gentlemen from the Tyler market," said Taylor. "He brought this to our attention. He actually brought it to my attention six months ago. We were tied up at the time. We got back to him. He came right over and presented it."

Greer said he considers the idea a "no-brainer."

"We keep the same stations we're getting now from Shreveport. It's just you're getting additional East Texas news



from Tyler and Longview stations, so it's a pretty good deal," he said.

Greer made the motion that the court approves the action to follow FCC rules of market modification by sending a letter to Direct TV and Dish Network to initiate "pre-filing coordination" for the feasibility study. Pct. 2 Commissioner Zephaniah Timmins seconded the motion.

"Theoretically the cable provider can ask us to do the same or seek our input," said Taylor. "I think they're eligible for modification also, so we'll cross that bridge when we get to it."

According to the overview of the process for requesting FCC to modify a broadcast station's local television market for cable or satellite carriage purposes, the Commission began accepting satellite market modifications petitions in February.

"The Satellite Television Extension and Localism Act Reauthorization (STELAR) Act of 2014 added satellite TV carriage to the Commission's market modification authority, which previously applied only to cable. The legislation recognizes that some satellite TV subscribers are not able to access their home state's news, politics, sports, emergency information, and other TV programming," market modification overview states. "This happens because of the way TV stations are defined as 'local' for purposes of satellite carriage."

In some cases, it means subscribers may be included in a local television market that is served exclusively, or almost exclusively, by television stations coming from a neighboring state.

"The STELAR and Commission's new satellite market modification rules help address this problem by adding flexibility to the current definition of a local television market for satellite carriage," the overview explains.

"The Commission's market modification rules provide a process for commercial broadcast TV stations, and the cable and now satellite operators that carry them, to request changes to the boundaries of their local television markets to include a new community located in a neighboring local television market."

"The rules enable a broadcast TV station to be carried on a cable system or satellite operator in such new community if the station can demonstrate a local relationship to such new community," the overview indicates.




Digital Broadcast Signal Maps




Sports views in Harrison County prefer carriage of Texas professional teams as opposed to Louisiana teams or other eastern U.S teams


I am writing in support of Harrison County's Petition for Special Relief (Petition) seeking to modify the local satellite carriage market for KFXK-TV and KLTV to include Harrison County in east Texas. As you know, I supported passage of the STELA Reauthorization Act of 2014 (STELAR) which included a provision extending the market modification process to satellite carriers. In STELAR, Congress ensured that when reviewing such petitions, the FCC shall pay close attention to the "value of localism" to promote consumers' access to television broadcast signals originating in their state of residence.

Receiving local in-state news coverage, including weather and emergency warnings, state and local government and elections, community events, and relevant local sporting events, is of the utmost importance to my constituents in Harrison County. Under the current Designated Market Area (DMA) such access is not available for satellite subscribers in Harrison County, leaving residents perplexed and frustrated. For example, a portion of the city of Longview falls within Harrison County. Under the current DMA, eastern Longview satellite consumers are unable to access local television broadcast stations such as KFXK-TV Fox51 Tyler/Longview, and instead receive Shreveport, LA based broadcasts.

I am encouraged that in response to local concern, the county government has taken the initiative to rectify the lack of local, Texas-focused and Texas-produced programming for their community. From my understanding, the Petition would significantly improve the availability of Texas based broadcast content, providing consumers with access to television stations of the most local interest to them.

Access to in-state programming is an important issue to east Texans. I hope the FCC will ensure the Harrison County Petition receives swift attention and that the agency move forward towards a quick resolution of this matter. The purpose of this letter is to urge support for the Petition for Special Relief submitted by Harrison County, Texas, regarding their delineation as an "orphan county." Subscribers in such "orphan" counties are unable to receive local programming from in-state DMA stations. Instead, they are serviced by out-of-state DMA stations and therefore cannot receive in-state local news, weather, sports, and educational programming. As a result, many of the residents Harrison County who are not serviced by cable companies have expressed concerns over being disconnected from their state and at risk of missing safety and emergency preparedness warnings.

The common-sense Petition is simply requesting that the television market of KLTV, Channel 7, ABC, Tyler/Longview, Texas, be modified to include Harrison County in northeast Texas with respect to satellite TV provider DISH Network and satellite TV provider DIRECTV. The FCC has the authority to do this under the STELA Reauthorization Act of 2014, which specifically notes situations such as that which affects constituents of mine in Harrison County. This is an issue that has lingered in Harrison County for years, and with the recent growth seen in Longview, it has made the issue all the more pronounced. It is absolutely vital that east Texans get east Texan news, news affects their everyday lives in uncountable ways.
