Dear Ms. Dortch:

South Dakota Network, LLC (“SDN”), by its attorneys, hereby submits amendments to Exhibit 1 of its Direct Case and Exhibit B of its *ex parte* letter of January 3, 2019. These amendments make corrections to the data provided in the respective exhibits. Pursuant to the Protective Order adopted by the Commission in this proceeding,¹ SDN requests confidential treatment for this information, which is commercially sensitive information that is not normally released to the public.

The amended Exhibit 1 to the Direct Case makes two corrections: first, it removes [REDACTED] minutes of use that were incorrectly included; second, it adds [REDACTED] minutes of use that were incorrectly excluded. The removed minutes were mistakenly identified as being associated with regulated services when, in fact, they are associated with non-regulated services and are therefore not relevant to SDN’s tariff. Conversely, the excluded minutes were mistakenly identified as being billed pursuant to contract when, in fact, they are billed under SDN’s tariff and are therefore relevant. These corrections align the methodology for compiling the 2018 numbers with the methodology for compiling the 2016 and

2017 numbers (which are unchanged), and with the numbers used to calculate SDN's benchmark. [REDACTED]

[REDACTED] SDN notes that these revisions do not affect its cost study, its filed rate, or its benchmark calculation.


The amended Exhibit B to the January 3 *ex parte* corrects a rate band allocation error [REDACTED]. These minutes were previously associated with subtending LECs that do not participate in the NECA tariff, but should have been included in the NECA tariff's rate band 8. As a result, SDN's calculated benchmark rate for equal access is \$0.012008. This is slightly higher than its original calculation of \$.01195.³ This revision does not affect SDN's cost study or its filed rate.

In accordance with the Protective Order and the Commission's rules, one redacted copy has been filed via ECFS; one confidential, non-redacted copy has been submitted via hand delivery to the Secretary's Office; and two confidential, non-redacted copies have been submitted via hand delivery to Mr. Christopher Koves.

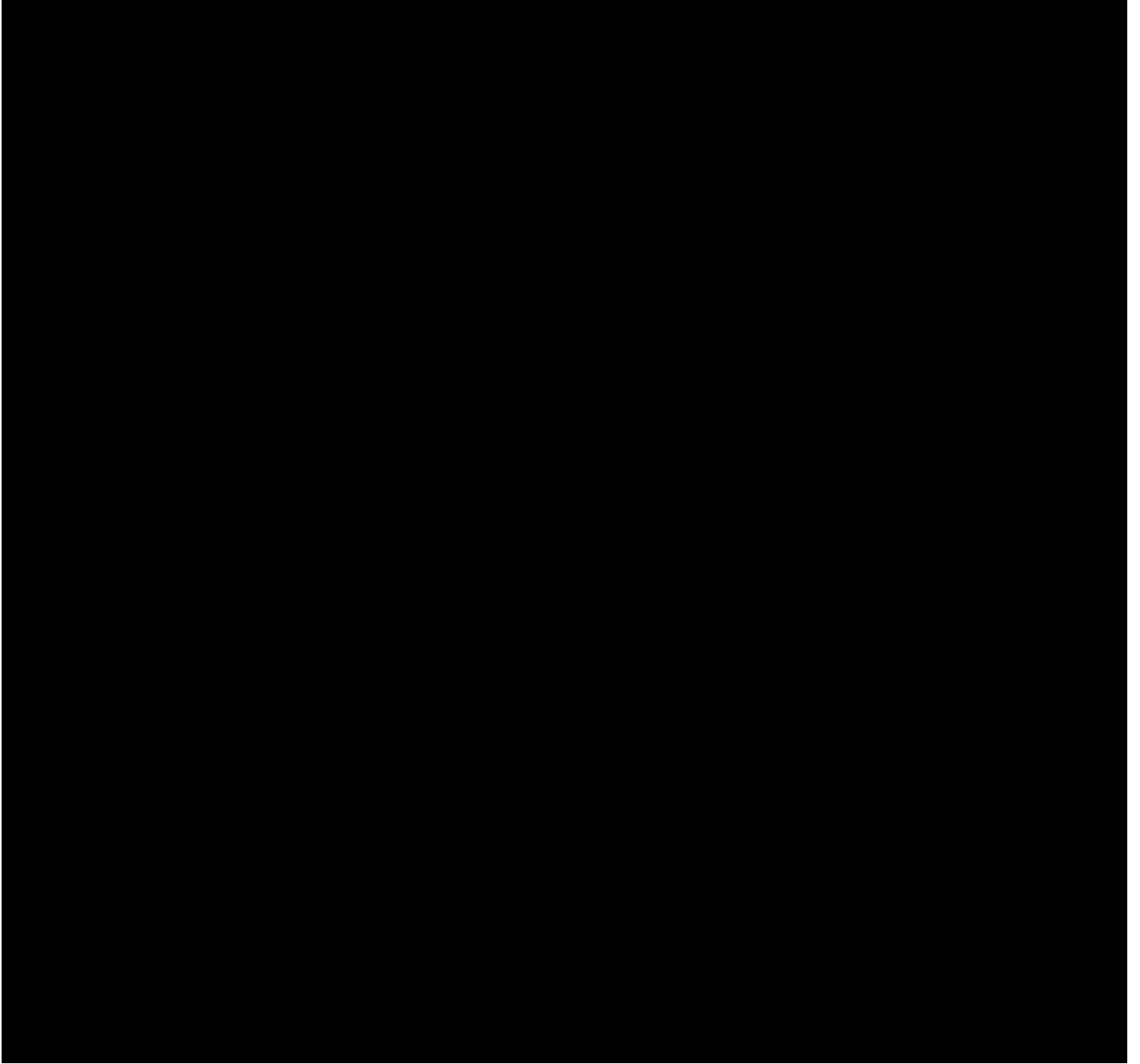

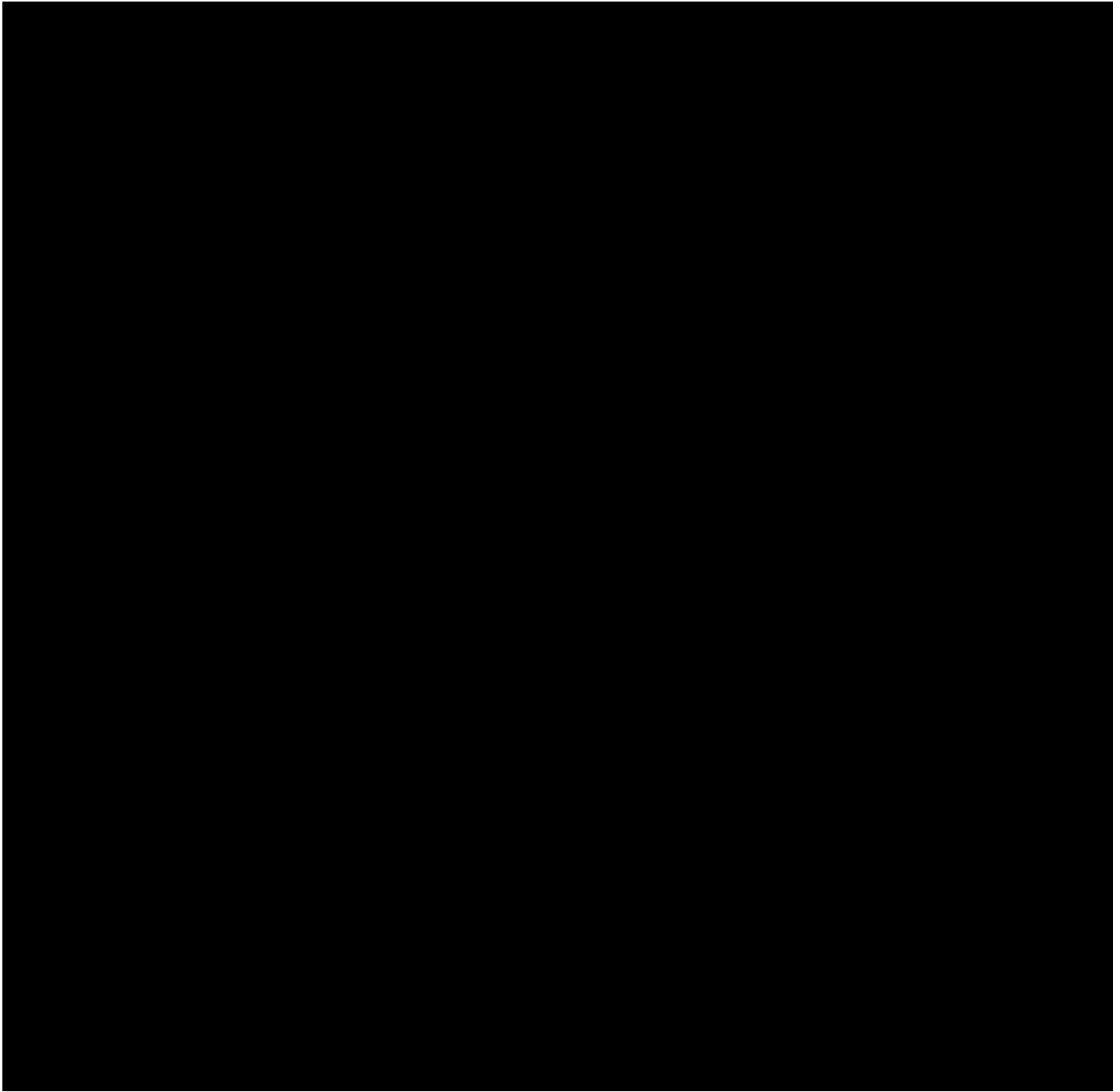
