The specific serving locations are listed on Attachment A. Frontier has deployed a fiber network in these areas and is already providing and offering services over a fiber network infrastructure. There are no customers that currently use the copper facilities that are being retired, and thus these facilities are eligible for 15-day processing. See 47 C.F.R. § 51.333(b)(2).

**Description of Reasonably Foreseeable Impact of the Planned Changes:**

For the locations reflected in Attachment A, Frontier will (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities.

Prior to Frontier's purchase of these facilities, Verizon had installed fiber in the above referenced wire center locations. No existing customers use services over these copper facilities reflected in Attachment A, and all affected locations are also served by fiber.

In accordance with FCC Rule 47 C.F.R. §51.333(a)(1), all telephone exchange service providers that are currently interconnected at this central office location are being notified. There are no impacted customers because no customers currently subscribe to services utilizing these copper facilities.
