Southwestern Bell Telephone Company d/b/a AT&T Texas intends to retire and remove a seventy-five foot (75') piece of two hundred pair copper feeder cable at an eighty-three (83) acre property located at 8230 Stedman Street, Houston, TX 77029. This property is currently located within distribution area (DA) 3128 in the Orchard wire center (HSTNTXOR) in Houston Texas. This property had been vacant for about a decade, and so there had been no request for services, and there will be no impact to customers from this action.

AT&T Texas plans to construct Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) facilities in preparation for any future developments in this area.

Description of Reasonably Foreseeable Impact of the Planned Changes:

After this plan is implemented and the work is completed, only fiber-based services will be available to serve the future occupants. AT&T Texas records indicate no working circuits, including competitive carrier circuits, on the eighty-three (83) acre property. Other parts of, or facilities in, DA 3128 (i.e. outside the 83 acres property) are not affected by this notice.
