## COMMENT AND REPLY COMMENT DATES SET FOR LOCAL PUBLIC NOTICE FNPRM

**MB Docket Nos. 05-6, 17-105, 17-264**

**Comment Date: November 18, 2019**  
**Reply Comment Date: December 2, 2019**

On September 26, 2019, the Commission adopted and released a Further Notice of Proposed Rulemaking in its proceeding to modernize and revise its rules for applicants providing local public notice of broadcast application filing.<sup>1</sup> The Commission sought comment on specific rule revisions designed to streamline and standardize its requirements for on-air and written notice of applications. The *FNPRM* set deadlines for filing comments and reply comments at 30 and 45 days, respectively, after publication of the *FNPRM* in the Federal Register.<sup>2</sup>

By this *Public Notice*, the Media Bureau announces that the *FNPRM* was published in the Federal Register on October 18, 2019.<sup>3</sup> Comments must be submitted no later than November 18, 2019. Reply Comments must be submitted no later than December 2, 2019. Commenters should follow the filing instructions provided in paragraph 44 of the *FNPRM*.<sup>4</sup> The *FNPRM* is also available on the Commission's website.<sup>5</sup>
