In response to an informal request from the Commission's staff, Gray Television Licensee, LLC ("Gray") licensee of broadcast television stations WVFX-TV and WDTV, hereby provides the Commission with the below ratings information, which is from Nielsen Media Research's 2005 County Coverage Study for Preston and Monongalia Counties. This is the most recent ratings information that Gray found in its stations' archives.

In 2005, Nielsen still relied on paper diaries to obtain ratings information for Preston and Monongalia Counties. Therefore, WDTV, WVFX, and WBOY-TV were able to achieve significant ratings at that time. Although Gray believes that WVFX(TV) likely achieved some measurable ratings in Preston County in 2005, Gray does not have in its archives any ratings information relating to WVFX in Preston County.


