Dear Ms. Monteith:

North Penn Telephone Company (the Company), Study Area Code 170192, hereby notifies the Wireline Competition Bureau of its intention to discontinue its present offering of broadband Internet access transmission service as a common carrier telecommunications service, effective April 2, 2018. As such, the Company will only offer broadband Internet access transmission service to its non-regulated ISP affiliate on a private carriage basis. The Company's change in this service offering will apply to its entire study area.

The Company currently provides its DSL transmission services on a detariffed basis, however, its Consumer Broadband-Only Loop service (CBOL) is provided pursuant to NECA Tariff FCC No. 5. The Company has requested from NECA that its tariffed CBOL service be removed from the NECA Tariff FCC No. 5, effective April 2, 2018. The Company provided notice to its nonregulated ISP affiliate, February 1, 2018, that the Company would be providing broadband Internet access transmission services, on a private carriage basis, solely to non-regulated ISP affiliate.
