Ms Putnam,

The Universal Service Administrative Company (USAC) has completed its evaluation of the appeal you submitted on behalf of Executive Systems, Inc. (Filer ID 829143), received on January 30, 2018 (below). In the appeal, you request that USAC waive the late filing fees of \$300 associated with the company's November 2017 FCC Form 499-Q, which appeared on the January 2018 invoice. You state that the late filing was the result of personal reasons.^[1]

USAC has reviewed your appeal and determined that your appeal seeks a waiver of the Federal Communications Commission (FCC or Commission) rules governing the assessment of late filing fees. Therefore, Executive Systems, Inc. must seek relief directly from the Commission and USAC hereby dismisses your appeal.

USAC will consider this matter closed unless you notify us within 30 days from the date of this email and provide a detailed explanation of any issues you believe remain outstanding. If you wish to appeal this decision to the FCC, you may file an appeal pursuant to the requirements of 47 C.F.R. Part 54, Subpart I.
