**Description of Reasonably Foreseeable Impact of the Planned Changes:**

AT&T Michigan, Independent LECs, Wireless Service Providers, CLECs and Interexchange Carriers may be affected due to changes in routing of originating and terminating traffic associated with the replacement of the TROYMIMNDS0 DMS100 switch. All interoffice trunking to the TROYMIMNDS0 switch must be re-homed to the WAYNMIMNCA1 C20 switch. Direct Inward Dial (DID) and Primary Rate Interface (PRI) ISDN service will be served from the TROYMIMNRPA G6 switch. CLECs must evaluate whether their existing trunk groups to TROYMIMNDS0 are still needed and must build them into WAYNMIMNCA1 to support TROYMIMNRPA traffic. Access Service Requests (ASR) or Local Service Requests (LSR) will be due by 3/19/18.
