We would like to appeal the decision by USAC to deny funding for FRNs 1699109418, 1699109422, 1699109429, 1699109434, 1699109441, 1699109448 and 1699109451 of form 471 # 161048133. We would also like to appeal FRN1699133264.

These FRNs were originally denied on 12/12/2016 among other FRNs for the following reasons:

*DR1: Applicant has not provided sufficient documentation needed to determine the eligibility of the following item(s): Vendor Documentation.;DR2: This FRN is denied because the funding request is duplicative of a current year's FRN. Program rules prohibit USAC from funding the same products and services to the same location in the same funding year.;DR3: Applicant has not provided sufficient documentation needed to determine the eligibility of the entity(ies) to be receiving service in this funding request.*

We appealed that decision with USAC and USAC approved some of the FRNs, however the above mentioned FRNs were denied on appeal. The reason given was "Your appeal has brought forward persuasive information that the appealed decisions should be partially overturned. However, USAC will be unable to provide funding for your request for the following reason(s): The record shows that this FRN was denied because the funding request is duplicative of a current year's FRN. Program rules prohibit USAC from funding the same products and services to the same location in the same funding year. You

*did not demonstrate during the appeal process that USAC erred in its initial decision. Consequently, USAC denies your appeal."*

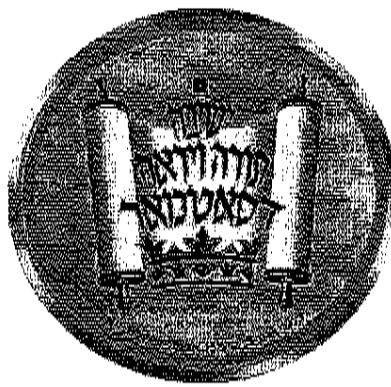
We are appealing this decision to the FCC because on our appeal to USAC we clearly demonstrated that none of the FRNs are duplicates. (After we sent our appeal to USAC, we did not receive any further requests from USAC.) We included a spreadsheet and included vendor proposals that clearly demonstrated that there are no duplicates in any of the FRNs. Specifically, FRNs 1699109418, 1699109434 and 1699109448 which are all for high-speed dedicated internet access, are each providing service for a separate location. It provided services to these three locations: Entities 16035574, 16044493 and 16044496. It also not a duplicate to FRN 1699109460 which is providing Point-to-point services (Transport only, not internet access) among these locations: 16044496, 16035574, 16044499, and 16044493. FRNs 1699109429, 1699109441, 1699109451 and 1699133264 which are all providing SIP services are each providing services to different locations. FRN 1699109429 is providing service to entity 16035574, FRN 1699109441 is providing service to entity 16044493 (this is not a duplicate to FRN 1699109444, which is providing 8 POT lines to this location, as these services are needed in addition these POT lines), FRN 1699109451 is providing service to entity 16044499 and FRN 1699109451 is providing service to entities 16066699, 16059581 and 16063447. FRN 1699109422 is also not a duplicate as it is proving PRI service to entity 16035574, which is needed in addition to the sip lines.
