Dear Ms. Dortch:

On February 11, 2019, on behalf of Broadnet Teleservices LLC (“Broadnet”), Steve Patterson of Broadnet, and Jennifer Tatel and the undersigned of Wilkinson Barker Knauer, LLP met separately with Commissioner Michael O’Rielly and Arielle Roth of Commissioner O’Rielly’s office; and Commissioner Brendan Carr and Jamie Susskind of Commissioner Carr’s office. During the meetings, we reiterated points made in Broadnet’s comments and reply comments in response to the Commission’s public notice on several issues related to the interpretation and implementation of the Telephone Consumer Protection Act (“TCPA”).<sup>1</sup> Specifically, we emphasized that the Commission should extend its conclusion in the *Broadnet Ruling*<sup>2</sup> that the federal government is not a “person” under the TCPA to state and local governments. In this regard, we addressed Broadnet’s December 3, 2018 letter and December 19, 2018 notice of ex parte presentation, which explain that Congress did not intend in enacting the TCPA to apply it to any government entities, whether federal, state, or local.<sup>3</sup>
