Sprint Corporation (“Sprint”) hereby submits additional materials with respect to the Federal Communication Commission’s (“Commission’s”) review of the proposed merger between Sprint and T-Mobile US, Inc. Sprint is submitting one hard drive labeled Hard Drive J and one flash drive labeled Flash Drive 8, each designated as “HIGHLY CONFIDENTIAL INFORMATION – SUBJECT TO PROTECTIVE ORDER IN WT DOCKET NO. 18-197 BEFORE THE FEDERAL COMMUNICATIONS COMMISSION.”

- Hard Drive J contains replacement images and load files associated with the log Sprint filed on February 8 regarding items that were inadvertently produced in previous document production filings. Sprint asks that the Commission immediately delete, destroy, or return to Sprint all copies of the privileged documents inadvertently produced, including their images, metadata, and any associated .dat file. Sprint is either withholding these documents in their entirety or providing a redacted version, as reflected in the replacement images and load file on Hard Drive J.
- Flash Drive 8 contains a spreadsheet identifying the zip codes associated with Sprint’s markets.
