At USAC, Julia has built strong relationships with executive staff including Catriona Ayer, Leslie Frelow, Jeff Walsh, John Noran and many others.

In her role as the West Virginia State E-rate Coordinator, she has led important programmatic changes, including permanent E-rate policy changes such as:

- Eligibility for telecommunications and Internal Connections (Category 2) in dormitories and housing for "special schools," through an approved waiver request.
- Launch of the Schools Spots initiative, also the result of a waiver request, permitting schools to utilize untapped broadband during off-hours.

Julia would be an excellent asset to the USAC Board of Directors not only due to her current role and experience, but also her energy, dedication, and strong work ethic. Her unique skill set and experiences would help her represent all school applicants.
