Re: Applications of T-Mobile US, Inc. and Sprint Corporation for Consent to Transfer Control of Licenses and Authorizations, WT Docket No. 18-197

T-Mobile US, Inc. (“T-Mobile”), by its undersigned attorney, hereby responds to the objection of CarrierX, LLC (“CarrierX”) to T-Mobile’s request to obtain access to the confidential version of the October 12, 2018, *ex parte* notification filed by CarrierX in the above-captioned proceeding.¹

The public version of CarrierX’s October 12 filing is not clear on its face that the information redacted is confidential information of CarrierX, as opposed to Highly Confidential Information (“HCI”) that T-Mobile had already placed in the record.² T-Mobile now understands that the filing contains CarrierX Confidential Information (“CI”) and, through its counsel, has issued a new access request to CarrierX’s counsel of record that attached the required Acknowledgements of Confidentiality executed by T-Mobile outside counsel and consultants.³ This new request meets the requirements of the *Protective Order* in this proceeding and qualifies T-Mobile counsel to access the confidential version of the filing.⁴

CarrierX asserts that T-Mobile should be denied access to the relevant *ex parte* because T-Mobile “has no use in this proceeding” for CarrierX’s confidential information.⁵ As T-Mobile previously noted, CarrierX has thus far failed to raise any issue relevant to the FCC’s merger

review, focusing instead on an unrelated private dispute currently in litigation.⁶ Regardless of the relevancy of any substantive claim thus far advanced by CarrierX, however, T-Mobile counsel is entitled to access submitted CI and HCI under the *Protective Order* in this proceeding in order to review the information and make a determination whether it is relevant or worthy of response.

CarrierX also contends that disclosure of the relevant *ex parte* filing to T-Mobile counsel would be improper because T-Mobile has objected to CarrierX accessing T-Mobile's CI and HCI.⁷ However, the T-Mobile Objection has no bearing on the ability of T-Mobile counsel to access CarrierX's CI. Unlike CarrierX counsel of record in this proceeding, the T-Mobile counsel seeking access to CarrierX's CI are not involved in the private litigation matter brought by CarrierX that involves similar claims to those raised by CarrierX in this docket. As a result, unlike CarrierX counsel, T-Mobile counsel will have no challenges in complying with the terms of the *Protective Order* and Acknowledgements.

For these reasons, the Commission should direct CarrierX to permit T-Mobile counsel access to the confidential version of CarrierX's October 12, 2018 *ex parte* filing.
