


SUPPLEMENT TO PETITION FOR RULE MAKING



This Engineering Statement has been prepared on behalf of ALEKI SENE, to request the allotment of an FM channel to Fagaitua, American Samoa.

This statement request a change in the FM Table of Allotments (Section 73.202 (b) of the Commission's Rules) to allot Channel 276C2 to Fagaitua, American Samoa, as that community's first local aural service.

There are only two FM assignment on the Island of American Samoa. They are Channels 221C3 and 266C1. Attached as Figure 1 is a list of these two stations both of which are assigned to Pago Pago.

The assignment of Channel 276C2 to Fagaitua will comply with the Commission's minimum distance rules to the two existing FM channels assigned to American Samoa.

Attached at Figure 2 is a map showing the Island of American Samoa and the reference site for Channel 276C2. The geographical coordinates of the reference site are as follows:
