


How Our Operating Procedures Ensure that Aeneas is in Compliance with CPNI Rules:

Aeneas management has adopted a CPNI Handbook for guidance of its employees. Employees are required to go through CPNI training as new hires and annually thereafter, in each event signing off on a post-training acknowledgement which is placed in their personnel file. Employees are reminded that disciplinary action may be taken for violation of CPNI policies.

Aeneas has a policy of not selling or sharing its CPNI with third parties for marketing purposes. It is Aeneas' policy not to use third party technicians to work on equipment that has access to CPNI. Should Aeneas change its policy, Aeneas will obtain a signed statement from any third party technicians concerning their CPNI responsibilities, if CPNI will be exposed in their work. Aeneas employs mass marketing directed to the public generally, and has not built a marketing program around CPNI; if we do, we'll keep a detailed record of it as required by CPNI Rules. Employees and supervisors are aware that accidental releases of CPNI must be reported and documented.

In 2017, there have been no customer complaints concerning the unauthorized release of CPNI. There also has been no actions taken against data brokers.

The company President and CEO reviews operations for CPNI compliance and has personal knowledge that the company has established and maintained operation procedures that are adequate to ensure compliance. The company President and CEO will sign off on the Compliance Statement form of this submission contemporaneously herewith.
