### **Re: Post-Transaction Notification of SkyLine Telephone Membership Corporation WC Docket No.: 17-177**

Dear Ms. Dortch:

Pursuant to Section 63.24(e)(4) of the Rules of the Federal Communications Commission (“FCC” or the “Commission”), 47 C.F.R. § 63.24(e)(4), SkyLine Telephone Membership Corporation (“SkyLine”) hereby notifies the Commission of the consummation on October 15, 2017, of the transaction effecting the transfer of control of the domestic Section 214 authorizations held by Chesnee Telephone Company, Incorporated d/b/a Chesnee Communications (“Chesnee Telephone”) and its wholly-owned subsidiary, Chesnee Long Distance, Inc. (“Chesnee LD”), to SkyLine.<sup>1</sup>

On July 14, 2017, the FCC issued a Public Notice in WC Docket No. 17-177 (DA 17-683), accepting the application for approval of the transfer of control of the domestic Section 214 authorizations held by Chesnee Telephone and Chesnee LD to SkyLine. On August 14, 2017, the Wireline Competition Bureau granted the application for transfer of control of the domestic Section 214 authorizations in a Public Notice issued in DA 17-766 (WC Docket No. 17-177).<sup>2</sup> The time for reconsideration or FCC review of the approval of the transfer of control expired on September 13, 2017, pursuant to 47 C.F.R. § 1.106.

The time period for reconsideration of the International Bureau’s action ran on September 16, 2017.
