Sprint Corporation (“Sprint”) hereby submits the following materials with respect to the Federal Communication Commission’s (“Commission’s”) review of the proposed merger between Sprint and T-Mobile US, Inc., each of which is designated as “HIGHLY CONFIDENTIAL INFORMATION – SUBJECT TO PROTECTIVE ORDER IN WT DOCKET NO. 18-197 BEFORE THE FEDERAL COMMUNICATIONS COMMISSION”:

- (1) One hard drive containing documentation from two additional custodians, labeled Hard Drive “F”;
- (2) One flash drive containing the privilege log associated with Hard Drive F, labeled Flash Drive 3; and
- (3) One flash drive containing replacement images and load files of Sprint that were inadvertently produced in previous document production filings, labeled Flash Drive 4.

With respect to Flash Drive 4, Sprint asks that the Commission immediately delete, destroy, or return to Sprint all copies of the privileged documents inadvertently produced, including their images, metadata, and any associated .dat file. Sprint is either withholding these documents in their entirety or providing a redacted version, as reflected in the replacement images and load file on the enclosed Flash Drive 4.
