Dear Sir/Madam:

By this letter, Nowalsky & Gothard, APLLC ("NG") hereby provides notice on behalf of UVNV, Inc. d/b/a Mint Mobile ("UVNV"), and Mint Mobile, LLC ("Mint") pursuant to Section 64.1120(e) of the Commission's Rules of the pending transfer of certain assets of UVNV to Mint. The parties propose a transaction whereby Mint will acquire those Commercial Mobile Radio Service customers of UVNV who were sold under the Mint Mobile brand. The transaction will not involve transfer of operating authority but will include a transfer of customers. In accordance with the requirements of Section 64.1120(e), NG submits the following information on behalf of the parties:

1. Name of parties to transaction:

Transferring Carrier: UVNV, Inc. d/b/a Mint Mobile ("UVNV")

Acquiring Carrier: Mint Mobile, LLC ("Mint")

UVNV and Mint are affiliates as defined by Section 3(1) of the Communications Act, as Amended. 47 U.S.C. § 153(1).

2. Types of telecommunications services to be affected:

Interstate and intrastate commercial mobile radio services.

3. Date of Transfer:

Upon receipt of the requisite regulatory approvals.

4. Certificate of compliance:

Attached hereto as Exhibit A is UVNV's certification of compliance with the requirement to provide advance subscriber notice in accordance with §64.1120(e)(3), with the obligations specified in that notice, and with other statutory and Commission requirements that apply to this streamlined process.

5. Copy of notice sent to affected subscribers:

Attached hereto as Exhibit B is the notice sent by UVNV to affected customers.

An additional copy has been enclosed to be date-stamped and returned in the envelope provided as evidence of the filing.


