On October 24, 2018, Howard M. Liberman and Jennifer L. Kostyu of Wilkinson Barker Knauer, LLP, outside counsel to Inmate Calling Solutions, LLC d/b/a ICSolutions (“ICS”) and Robert E. Stup Jr. and Peter M. Bean of Squire Patton Boggs (US) LLP, outside counsel to Securus Technologies, Inc. (“Securus”), held a telephonic conference call with Daniel Kahn, Division Chief, Competition Policy Division (“CPD”), Wireline Competition Bureau (“WCB”), Terri Natoli, Deputy Division Chief, CPD, and Jodie May, Assistant Division Chief, CPD.

The participants discussed the Commission’s requirements under the Information and Document Requests issued by the WCB on September 11, 2018 in the above-referenced docket,<sup>1</sup> particularly the requirements under Request Number 19.
