The application seeks Commission approval for the discontinuance of retail voice services that are branded Merrimac Communications to 7 commercial customers in the Hillsboro, Fitchburg, Sun Prairie, Oregon, Madison and Milwaukee, Wisconsin market areas. The discontinuance will occur on December 16, 2019. TDS Metrocom acquired substantially all of the assets of Merrimac Communications¹, including its retail customers and cable franchise. TDS Metrocom has permission to use the Merrimac Communications name until all customers are removed from the legacy network.

**SECTION 63.71 APPLICATION OF
TDS METROCOM, LLC**

TDS Metrocom, LLC ("Applicant") seeks authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. §214(a) and Section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue its provision of all Voice services to 7 commercial customers at certain addresses in the Hillsboro, Fitchburg, Sun Prairie, Oregon, Madison and Milwaukee, Wisconsin Market Areas. This action is a result of TDS Metrocom efforts to decommission Merrimac's legacy network. The Applicant provides the following information pursuant to Section 63.71 of the Commission's Rules:

1. Name and Address of the Carrier: TDS Metrocom, LLC, 525 Junction Road, Madison, Wisconsin 53717.
2. Date of Planned Service Discontinuance: Applicant plans to discontinue the affected services on December 16, 2019. Applicant understands that this Application will be granted automatically on the 31st day after public notice of its filing unless the Commission notifies Applicant to the contrary.
3. Points of Geographic Areas of Service Affected: Applicant proposes to discontinue the affected services to certain customers in the Hillsboro, Fitchburg, Sun Prairie, Oregon, Madison and Milwaukee, Wisconsin market areas.
4. Description of Service Affected: The services to be affected are all voice services.
5. Brief Description of the Dates and Methods of Notice to All Affected Customers: Applicant mailed a written notification of the planned discontinuance to the impacted customers utilizing the services in accordance with Section 63.71(a) of the Commission's Rules. Customer notifications were

mailed via first-class U.S. Postal mail on October 28, 2019. Selected sample copies of the notifications are attached to this application.

6. Regulatory Classification of Carrier: Applicant is considered non-dominant with respect to the services to be discontinued.

7. Other Information: In accordance with Section 63.71(a) of the Commission's Rules, a copy of this application is being mailed concurrently with its filing to the Governor of Wisconsin, the Wisconsin Public Service Commission and the Special Assistant for Telecommunications to the Secretary of Defense. Please direct questions regarding this application to the undersigned.

8. Circumstances of Discontinuance: The Affected Services are provided to the customer's locations via a legacy network being decommissioned. Affected customers will have sufficient time to make arrangements to obtain service from another service provider.

Conclusion: The public convenience and necessity will not be adversely affected by the discontinuance of the services described herein. Advance notice has been provided to all affected customers, giving them ample time to arrange for substitute services readily available from other providers. Therefore, Applicant respectfully requests that the Commission approve this Section 63.71 application.²
