Clarification Filed by the P2P Alliance

Attached is yet another example that proves the P2P Alliance is a sham! The claim that a two way conversation ever occurs with a P2P platform is a blatant lie.

In the attached a preposterous claim is made that a click monkey can converse with 1,500 text message call recipients in an hour: "Each agent can send out around 1500 texts in the span of an hour..." It is a physical impossibility for one person to converse one on one with 1,500 individuals in one hour.

And again the same false claim is made that P2P texting is TCPA compliant: "Since agents are manually hitting the send button for every text, with texts going out from a ten digit number, p2p texting stays compliant of texting regulations."

If the Commission creates an exemption for P2P texts and P2P robocalls the robocall epidemic will increase drastically and overrun our telecommunications network. The

Commission must not fall for the lies from petitioners such as the P2P Alliance whose sole interest is in circumventing and neutering the TCPA.

The Commission needs to step up to the plate now and address these lying petitions expeditiously and firmly! Ignoring these petitions or taking years to decide on the petitions leads inevitably to what we see today - a false claim that the calling platform is TCPA compliant. Deny the petition or condone the takeover of our telecommunications network by text and robocall blasters who have no respect for consumer privacy.

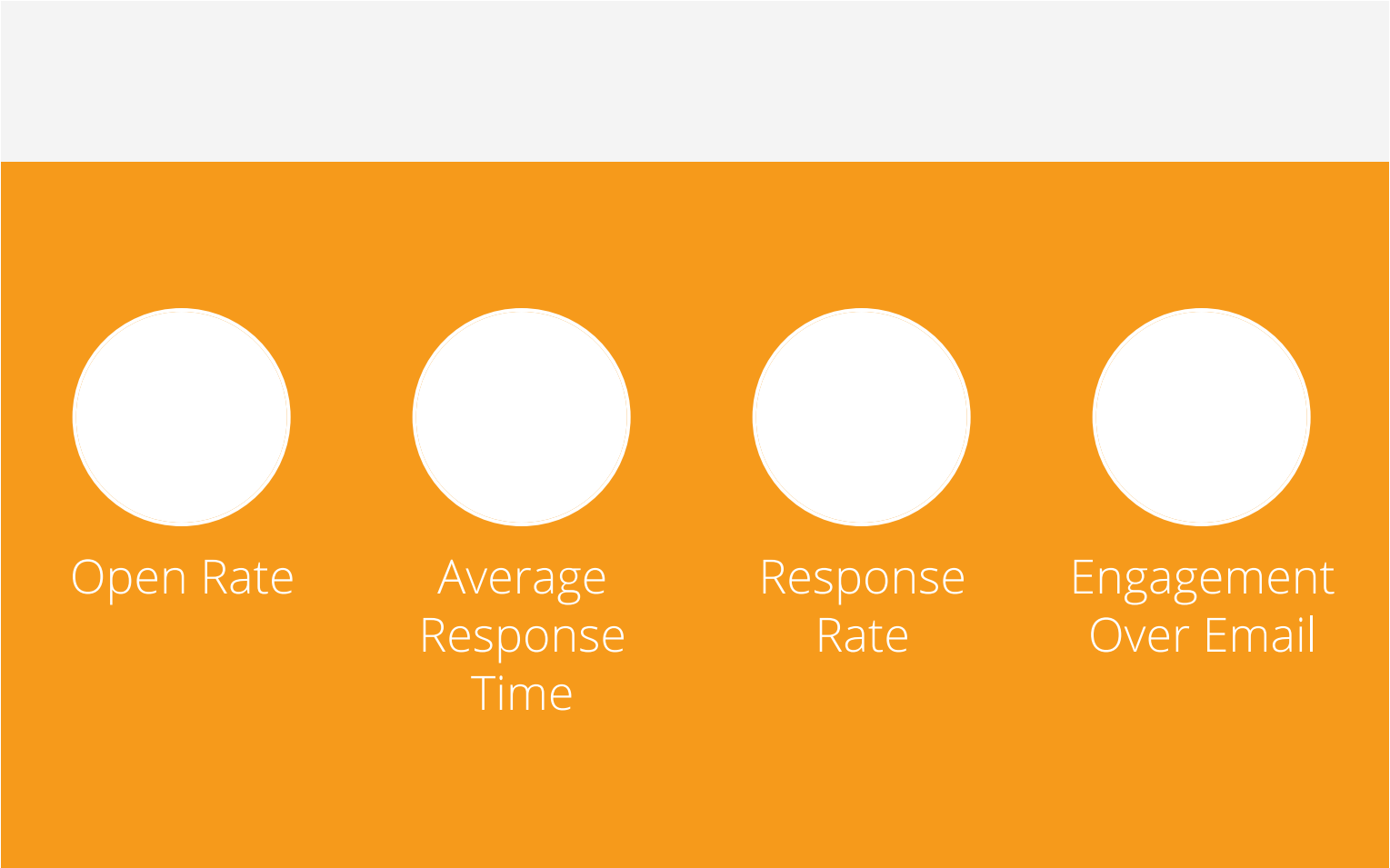

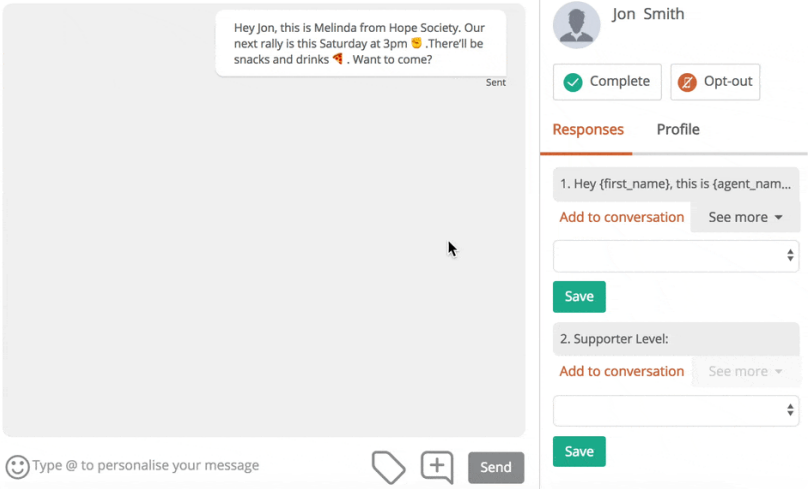
What is peer to peer texting?

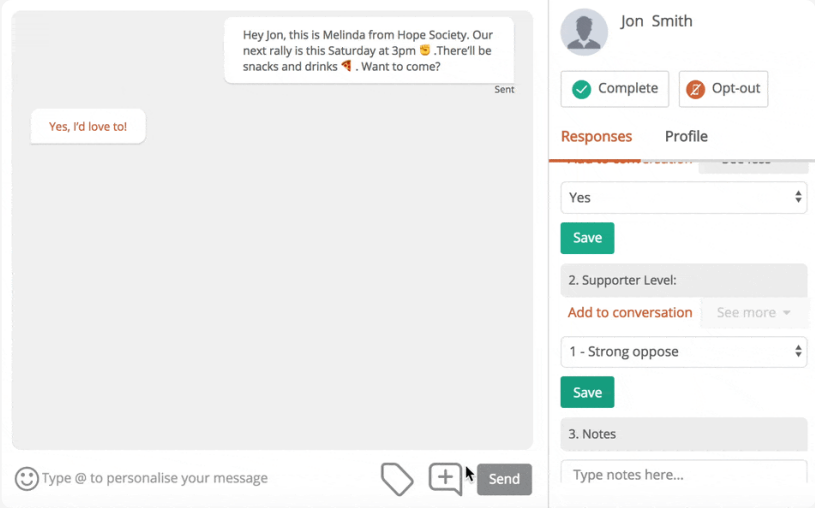

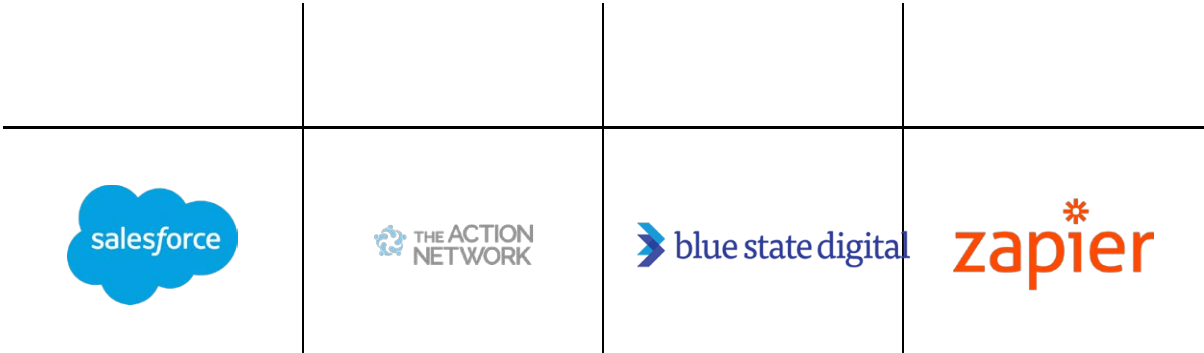
