I, William Davenport, Senior Vice President & Deputy General Counsel, Regulatory Affairs of Ligado Networks Subsidiary LLC (“Ligado”), certify that I am an officer of Ligado, and acting as an agent of the company, that I have personal knowledge that Ligado has established operating procedures that are adequate to ensure its compliance with the Commission’s CPNI rules. *See* 47 C.F.R. § 64.2001 *et seq.*

Attached to this certification is an accompanying statement explaining how Ligado’s procedures ensure that the company is in compliance with the requirements set forth in Section 64.2001 *et seq.* of the Commission’s rules. As explained therein, because Ligado does not have access to any CPNI, such compliance is assured.

Ligado has not received any customer complaints in the past year concerning the unauthorized release of CPNI.

Statement Regarding Compliance with CPNI Regulations

Ligado Networks Subsidiary LLC (“Ligado”) is authorized to operate as a common carrier in the United States. However, at this time Ligado is not providing any telecommunications services to end-user customers. Rather, Ligado operates as a wholesale provider of satellite services. Ligado does not have access to CPNI related to the end users served by Ligado’s wholesale customers, which hold all CPNI with respect to those end users. Because Ligado does not have access to any such CPNI, compliance with the Commission’s CPNI rules is assured. Nevertheless, we note that Ligado previously had implemented a robust CPNI compliance program, and that Ligado would implement a similar program if, in the future, it begins providing telecommunications services to end users or otherwise has access to CPNI.
