Pursuant to our earlier discussions with Alexander Sanjenis of the Commission's staff, we hereby submit the following on behalf of our client, Pan Caribbean Broadcasting De P.R., Inc. (the "Licensee") which is the licensee of WMDD (Fajardo, P.R.) and WZIN (Charlotte Amalie, V.I.):

Due to the damage caused by Hurricanes Irma and Maria last year, the Licensee continues to encounter significant difficulties for both of its stations: internet service continues to be intermittent, some employees have had to leave, basic operations including accounting and revenue collection has been disrupted, and management has had to focus its attention on numerous additional tasks simply to maintain service. While it has made good faith efforts to comply with the online public file requirement, the Licensee is unable to meet today's deadline. Accordingly, the Licensee hereby requests an additional two months to comply with the online public file requirement.
