Re: Sprint's Status Report on 800 MHz Band Reconfiguration
WT Docket 02-55

Dear Mr. Furth:

Sprint Corporation ("Sprint") hereby files this update regarding 800 MHz band reconfiguration progress with the Federal Communications Commission ("Commission") and the 800 MHz Transition Administrator, LLC ("TA").¹

Band reconfiguration continues to make significant progress across the United States. All 800 MHz public safety and non-public safety licensees required to be retuned in a total of forty-four NPSPAC Regions and the U.S. Territories have fully completed 800 MHz band reconfiguration.²

Currently only 11 Regions of the 55 NPSPAC Regions remain incomplete. Notably, however, only one individual public safety licensee (non-NPSPAC) remains to fully complete 800 MHz band reconfiguration in the Nevada NPSPAC Region³ and one commercial licensee remains in the Oklahoma, Arkansas, Dallas, Austin and Lubbock NPSPAC Regions⁴. All other public safety retuning is complete in these five non-Border NPSPAC Regions. In addition, in the Border markets of Arizona and New Mexico these Regions are nearly complete. In Arizona, two non-public safety licensees remain⁵ and in New Mexico, one public safety and one non-public safety licensee remain⁶. The following is a map showing the status of each NPSPAC Region:

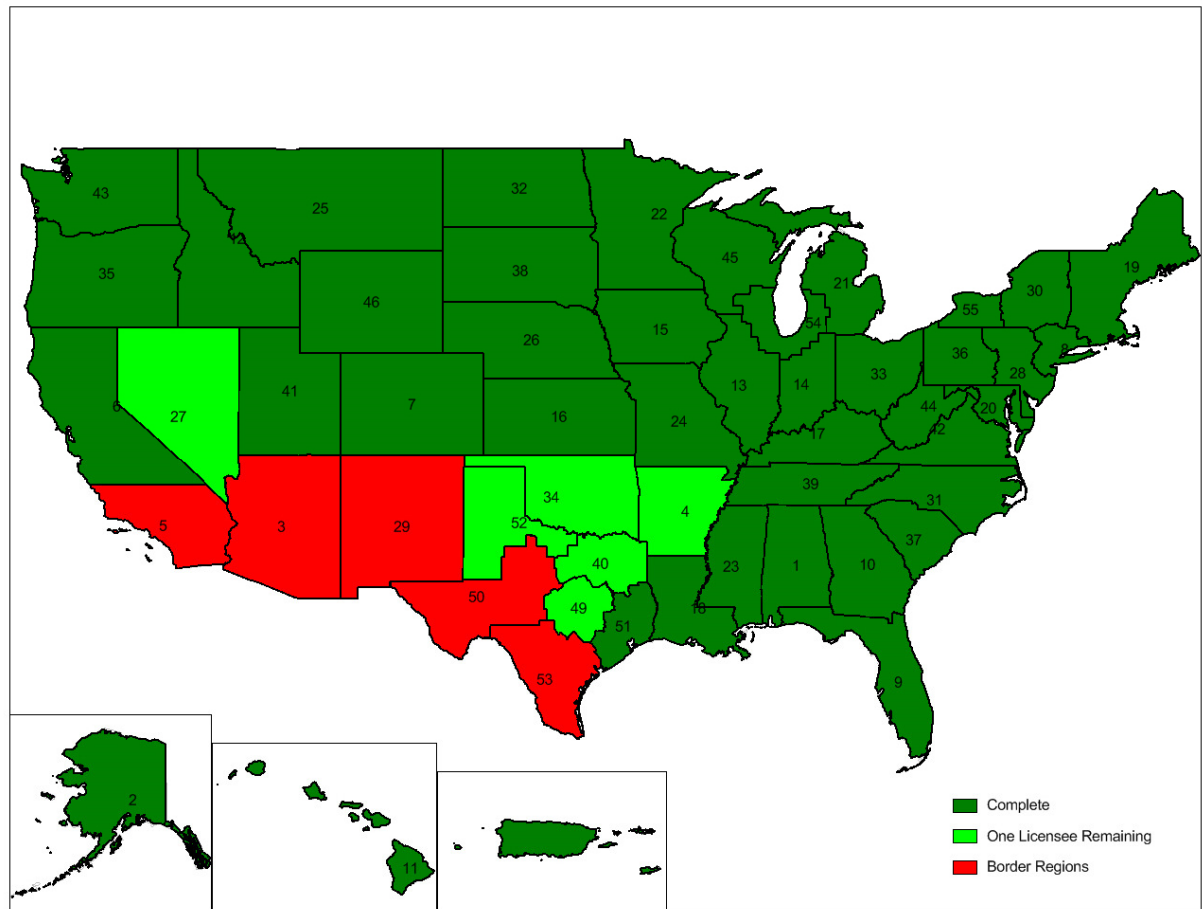

Consistent with previously filed monthly reports, Sprint hereby provides additional details regarding the status of 800 MHz band reconfiguration.

For Phase I, Sprint has completed the retuning of all non-Sprint, non-Southern LINC Channel 1-120 incumbent licensees (over 1200 overall) in all fifty-five NPSPAC regions and all of the U.S. Territories. *See* Figure 1.

Sprint and Southern LINC have completed all retuning activities in the southeastern United States including Southern LINC clearing its operations from the lower 1-120 channels. *See* Figure 2.

For Phase II, one-hundred percent of all licensees who must be retuned have signed FRAs, including all non-border, all U.S. – Canada Border, all Puerto Rico and all U.S. – Mexico Border Area licensees – nearly 1200 FRAs overall. In addition, seventy-nine retunes (out of 155 necessary) are complete in the U.S. – Mexico Border Area (51%). As described above, Sprint is virtually complete in Arizona and New Mexico, including in the U.S. – Mexico Border Areas.

In all 55 NPSPAC Regions and territories Sprint has cleared its operations from the 1-120 channels (the “new NPSPAC” band) and, pursuant to the FRAs with individual incumbent licensees, has made all of these channels available to NPSPAC licensees to complete their retuning in accordance with their schedules. *See* Figure 3.

As demonstrated in Figure 4, over 1100 NPSPAC and non-NPSPAC licensees have established with Sprint a firm date for starting and completing their physical retuning work and most have, in fact, finished their retunes. These figures include U.S. – Mexico Border Area retunes which have now begun in earnest. *See* Figure 4.

Based on this progress, Sprint also continues to work closely with the 800 MHz TA to verify Sprint and the public safety’s ongoing progress towards completion of rebanding on a NPSPAC-region-by-NPSPAC-region basis. Verification of this benchmark progress will continue to allow Sprint to make additional 800 MHz “interleaved” spectrum available to the Commission for relicensing for new systems and system expansion.

Sprint appreciates the continuing opportunity to update the Commission on the substantial progress being made in 800 MHz band reconfiguration. We remain available to discuss this Report at the Bureau’s convenience. Sprint remains committed to completing this important initiative; however, as the information contained herein demonstrates, Sprint cannot complete 800 MHz band reconfiguration until all affected incumbent licensees complete their individual retuning activities.
