PLEASE NOTE:

- All references to the East Northport NY DMS switch are associated with CLI code ENPTNYENDS0 and will not be repeated throughout this notice.
- All references to the Deer Park NY CS2k switch are associated with CLI code DRPKNYDPPS0 and will not be repeated throughout this notice.

Description of the Planned Network Change(s):

The Verizon East Northport DMS switch, located at 706 First St. N., East Northport, NY 11731, will be retired and removed from the network after all traffic served by this switch is migrated to the Verizon Deerpark CS2k switch, located at 85 W. Second St., Deer Park, NY 11729. All traffic to be migrated includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC/IXC), wireless, and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Deerpark CS2k switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the East Northport DMS switch will be required to reposition the codes to the Deerpark CS2k switch.

All ASRs for the Deerpark CS2k switch must be received no later than June 20, 2019 to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the East Northport switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the East Northport DMS switch (**on or after August 1, 2019**). This will serve to guide interconnect re-routes of traffic for the nine (9) native codes currently served by the East Northport DMS switch to reflect the Deerpark CS2k switch as the new home switch. All ASRs for the Deerpark CS2k switch must carry the project code of **ENPTNYENDS0**.
