Re: Tennessee Telephone Company - Notice of Network Change

Dear Ms. Dortch:

Pursuant to Section 51.325 – 51.335 of the Commission's rules, Tennessee Telephone Company ("TN Tel") hereby submits the attached: Certification of Public Notice of Network Change under rule 51.329(a); Public Notice of Copper Retirement under rule 51.333; and Certification of Public Notice of Copper Retirement under rule 51.333. Specifically, Concord is providing notification of the replacement of copper distribution and loop facilities with fiber-to-the-home facilities in a certain digital service area (DSA) located in Mt. Juliet, TN. Upon completion, TN Tel will provide services through its fiber optic network.

All of the customers served by copper at these locations purchase "plain old telephone service" (POTS). Following transition to fiber, TN Tel will continue to offer these customers the same POTS service over fiber at the same or better price as they received on copper facilities. There will be no change in the underlying features and functionalities in their service; this is not a transition to IP-based service, and TN Tel will offer these customers the same regulated service they have today.

Description of the Planned Network Change(s):

Tennessee Telephone Company intends to retire a number of copper facilities in the DSA locations listed on the attached Exhibits to provide services over a fiber network infrastructure. Tennessee Telephone Company has deployed its fiber-to-the-home network in the areas identified in Exhibits A.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

After the retirement of the copper facilities, Tennessee Telephone Company will: (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities.
