Re: FCC Rule Waiver Request for Live Milwaukee County Wireless Emergency Alert (WEA) Test

Dear Deputy Chief Cooke:

The Milwaukee County Office of Emergency Management (OEM) would like to submit a request for a waiver of FCC Rule 47 CFR Part 10 on behalf of participating commercial mobile service providers to conduct the following live-code Wireless Emergency Alert (WEA) test of the Milwaukee County Emergency Alert System using Everbridge (enclosed, pages 3-4):

- **1345 hours CDT on Thursday, April 11, 2019**, in the broad "All-County" polygon

The test will be conducted by OEM, which is the primary alert and warning authority for the Integrated Public Alert and Warning System (IPAWS) in Milwaukee County. The text of the test is fewer than 90 characters and will read:

"This is a TEST of the Milwaukee County Wireless Emergency Alert System. No action needed."

Following the test, OEM will assess message receipt and work to address any issues that result. This test would not substitute for the required monthly EAS tests performed in conjunction with local broadcasters.

We believe two reasons provide sufficient justification of "good cause" required for a waiver:

1. Milwaukee County believes it is imperative to test the system before the FCC's WEA end-to-end testing rules become effective in May 2019. Southeastern Wisconsin is entering the severe spring flooding season, and though rare, tornadoes have been recorded in Milwaukee County as early in the season as March 8. Waiting until May to implement a program designed to deliver immediate warnings may endanger public safety and put lives at risk unnecessarily.

2. Wisconsin's Tornado & Severe Weather Awareness Week, co-sponsored by the National Weather Service (NWS) and Wisconsin Emergency Management (WEM), is scheduled for the week of April 7. By leveraging the existing opportunity to introduce the WEA test concurrent with the statewide tornado drill on April 11, OEM can capitalize on longstanding public awareness campaigns to increase understanding of WEA. In addition to aligning our messaging with WEM and other counties' campaigns, we will be able to broaden our reach without added expense.

On March 19, OEM will conduct a test of the WEA system in the FEMA IPAWS Lab Environment and Alert Viewer to ensure that OEM officials are able to test and validate OEM's IPAWS origination capabilities to disseminate emergency messages to the public before conducting a live test.

OEM has prepared a comprehensive communications plan (enclosed, page 5) and has notified all stakeholders (enclosed, pages 6-14) of the planned tests, including all local CMS providers, elected officials, law enforcement, fire/EMS agencies and public safety answering points (PSAPs), to ensure they are aware of the test and will confirm to the public that the WEA messages are in fact only a test.

Additionally, OEM will engage the other county emergency management agencies that comprise WEM's Southeast Region, including the counties of Jefferson, Kenosha, Ozaukee, Racine, Walworth, Washington, and Waukesha. Comprehensive public information campaigns will be executed no later than one week before each test, to educate the public on this new capability and assure them that the WEA alerts are only a test.

2019 WEA TESTING PLAN

OVERVIEW

OEM aims to assess the Milwaukee County Wireless Emergency Alert System and establish an acute measure of accuracy of one polygon via Everbridge polling results.

Preparations for these assessments to date include:

- Drawing a polygon in ESRI.net, "All-County"
- Practice testing against the IPAWS Lab Environment and Alert Viewer
 - ✓ FEMA Lab test completed successfully on 09/09/2018 at 1548hrs and 2110 hours
 - ✓ FEMA Lab test scheduled for 03/19/2019
- Outlining process for end-to-end testing, obtaining results, drafting AAR
- Creating contact lists for stakeholders, elected officials, media targets
- Developing an Everbridge sign-up/update campaign for all County employees

Following a planned test in the FEMA Lab, OEM will initiate a semiannual testing of the All-County polygon, scheduled to coincide with established public safety awareness weeks, sponsored by Wisconsin Emergency Management and the National Weather Service:

- April 8-12, 2019 **Tornado & Severe Weather Awareness Week**
- November 4-8, 2019 **Winter Weather Awareness Week**

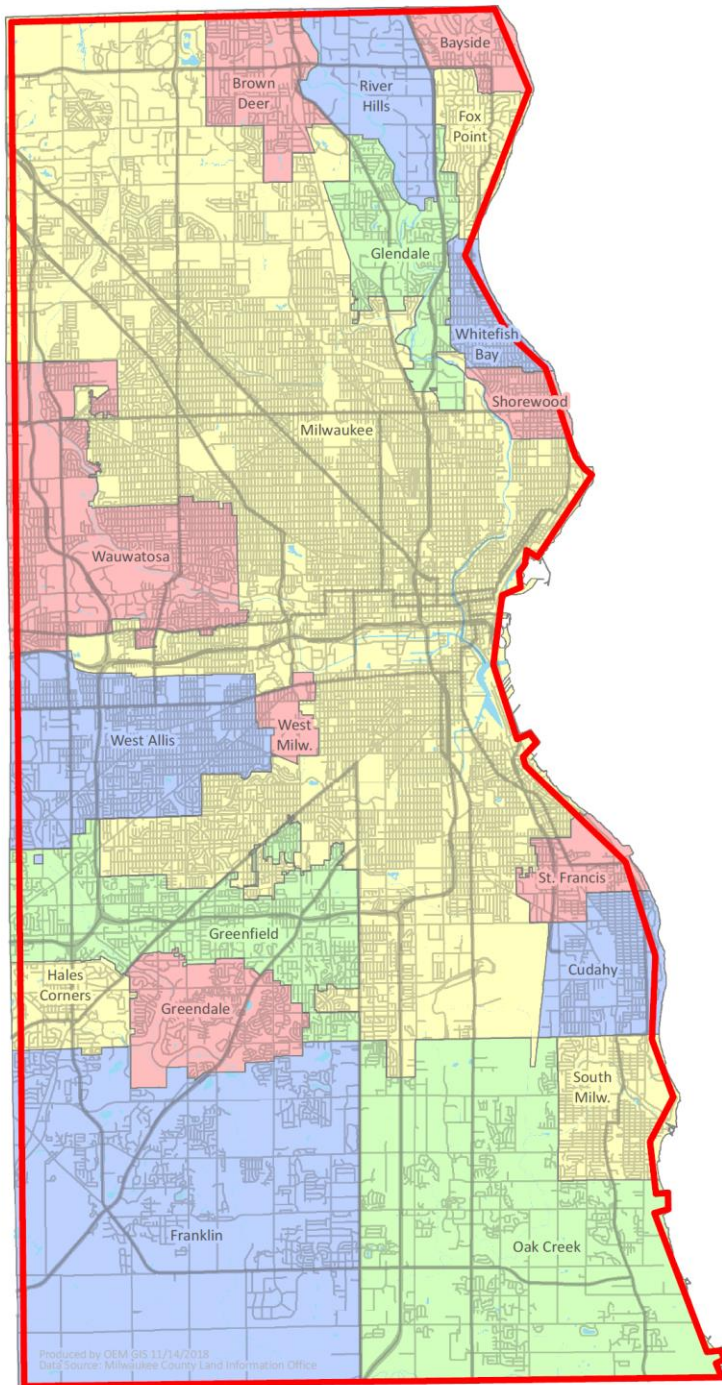

Countywide testing will occur twice yearly in coordination with scheduled tornado and winter weather drills:

Tornado Awareness Week

April 11 at 1:45pm

Winter Weather Awareness Week

November 6 at 12:00noon

Mobile phone users located within the borders of Milwaukee County at the time of the test may receive an alert that looks like a text message, with a special repeated tone and vibration.

Alerts received at the right time can help keep you safe during an emergency. With Wireless Emergency Alerts (WEA), warnings can be sent to mobile devices of individuals who may be in harm's way, without a special app or subscription.

WEA messages are text messages sent through mobile carriers in designated geographic areas, similar to how mobile phones receive AMBER alerts.

Beginning next month, the Milwaukee County Office of Emergency Management (OEM) will be authorized by the Federal Communications Commission (FCC) to issue WEA messages. OEM will conduct two WEA tests in 2019:

About Wireless Emergency Alerts

WHAT ARE WIRELESS EMERGENCY ALERTS?

Wireless Emergency Alerts (WEA) are emergency messages sent through your mobile carrier by authorized government alerting authorities, such as:

- FEMA
- National Weather Service
- Wisconsin Emergency Management
- Milwaukee County OEM

Alerts received at the right time can help keep you safe during an emergency. With WEA, warnings can be sent to your mobile device when you may be in harm's way, without a special app or subscription.

WHAT TYPES OF ALERTS WILL I RECEIVE?

Tornado Warnings, Blizzard Warnings, Extreme Wind Warnings and Flash Flood Warnings in Milwaukee County; AMBER Alerts; Presidential Alerts during a national emergency. Follow any action advised by the message. Seek more details from local media or authorities.

WHAT DOES A WEA MESSAGE LOOK LIKE?

WEA will look like a text message. The WEA message will show the type and time of the alert, any action you should take, and the agency issuing the alert. The message will be no more than 90 characters. WEA messages include a special tone and vibration, both repeated twice.

WHEN WILL I RECEIVE WEA MESSAGES?

Milwaukee County OEM will begin regular testing of the WEA system in April 2019. In an actual emergency, you may receive multiple messages as conditions change.



HOW DOES WEA KNOW WHERE I AM?

Just like emergency weather alerts you see on local TV, WEAs are broadcast from area cell towers to mobile devices in the area. Every WEA-capable phone within range receives the message, just like TV that shows the emergency weather alert. WEA, like the TV station, doesn't know exactly who is tuned in.

WHAT IF I DON'T WANT WEA MESSAGES?

We don't recommend it, but you can opt-out of receiving WEA messages for all but Presidential messages. To opt out, adjust settings on your mobile device.

WHAT IF MY DEVICE ISN'T WEA-CAPABLE?

WEA is only one of the ways you receive emergency alerts. Other sources include NOAA Weather Radio, news broadcasts, the Emergency Alert System on radio and TV programs, outdoor sirens and internet services.
