
Dear Ms. Dortch:

Pursuant to the notification requirements in 47 CFR §51.325 - §51.335, Hawaiian Telcom, Inc. ("HTI" or "Company") submits this Certification of a Public Notice of Copper Retirement. This notice is to advise that copper distribution and loop facilities will be replaced with fiber-to-the-premises facilities at specific locations currently served by the Kaaawa central office.

Most of the affected customers subscribe to "plain old telephone service", or POTS. After the conversion to fiber facilities, HTI will continue to offer these customers the same POTS service, with no changes to price, features or functionality.

Description of the Planned Network Change(s):

Hawaiian Telcom intends to retire copper facilities at locations in the Kaaawa wire center listed in the attached Exhibit A. Hawaiian Telcom has deployed or plans to deploy its fiber-to-the-home network in the areas listed above and intends to provide services over a fiber network infrastructure.

Description of reasonably foreseeable impact(s) of the planned change(s):

After the retirement of the copper facilities, Hawaiian Telcom will: (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities.

Description of any changes in prices, terms, or conditions that will accompany the planned change(s):

As a general matter, the retirement of copper facilities will not result in changes to rates, terms, and conditions in cases where the affected service is converted to a like-for-like service that is available on fiber facilities. In cases where interconnecting entities elect to replace the affected service with an alternative service that Hawaiian Telcom offers on fiber facilities, the rates, terms and conditions will be as set forth in the tariff or agreement under which Hawaiian Telcom offers the replacement service that the interconnecting entity selects..
