**PETITION FOR CLARIFICATION**

TeleQuality Communications, LLC (TeleQuality) respectfully requests that the Wireline Competition Bureau clarify two aspects of its recent Public Notice regarding the determination of rural rates in the Rural Health Care (RHC) Program for Funding Year 2019.<sup>1</sup> First, TeleQuality asks the Bureau to clarify that a service provider using the third method of determining rural rates described in the *Public Notice* need not submit its rates to the Federal Communications Commission (Commission) or the relevant state commission before it responds to a rural health care provider’s (HCP’s) request for bids. Second, TeleQuality asks the Bureau to clarify what kind of documentation will satisfy the “publicly available rates” requirement.

**I. The Bureau Should Clarify That Service Providers Need Not Submit Their Method 3 Rural Rates to the Commission or a State Commission Before Submitting a Bid**

The *Public Notice* provides additional guidance on the three methods of determining rural rates described in the Commission’s rules.<sup>2</sup> The *Public Notice* also states that “[a] service provider should determine the rural rate *before* it responds to a health care provider’s request for

bids (FCC Form 465) and ensure that the rate is sufficiently documented at that time.”<sup>3</sup> The service provider can and must determine its rural rate before it responds to an HCP’s request for bids. It is unclear, however, whether the Bureau, in directing service providers to “ensure that the rate is sufficiently documented at that time,” means that service providers must submit their rural rates for approval to the Commission or the state commission prior to submitting a bid.

TeleQuality respectfully asks the Bureau to clarify that these statements should not be interpreted to impose a requirement for vendors using Method 3 to submit the rural rate for approval to the relevant regulatory body before a bid is submitted.<sup>4</sup> The Commission has not previously stated that service providers using Method 3 must submit rates to the Commission or a state commission before submitting bids. Because such a requirement would be onerous and time consuming at best, and impossible at worst, TeleQuality asks the Bureau to clarify that it did not in fact intend to impose a new timing requirement.

Method 3 allows service providers to seek approval of cost-based rural rates from the Commission or a state commission, depending on whether the services are interstate or intrastate.<sup>5</sup> Although a provider may use Method 3 only if it is unable to determine a rural rate using Methods 1 and 2, as a practical matter a provider such as TeleQuality—which does not serve non-HCPs and has found it challenging to identify publicly available rates for similar

services to rural HCP locations—is likely to use Method 3 for a significant portion of its rural rates.<sup>6</sup>

TeleQuality asks the Bureau to clarify this requirement for two main reasons. First, a service provider does not know at the bidding stage whether new circuits will be used for interstate or intrastate services, as HCPs do not specify the regulatory classification of the telecommunications service in their requests for bids. Without knowing whether it will be providing interstate or intrastate services (or both), a service provider does not know which entity to seek approval from: the Commission, or the relevant state commission. To be on the safe side, service providers would have to seek approval from *both* the FCC and state commissions for all rates they bid, which would waste company and regulatory administrative resources and may even make it impossible for a service provider to submit a bid by the due date.<sup>7</sup> Further, a service provider may be required to resubmit the state or federal filing multiple times within a few months, depending upon the number of bids it is submitting within a given state, which may create even more additional work for state and federal regulators. It is thus unreasonable to require a service provider to obtain regulatory approval for rural rates before submitting bids.

Second, such a filing with a state commission or the Commission just prior to a service provider responding to a bid request is anti-competitive. TQ is a company that exclusively serves HCPs. Any public filing it makes will identify for its competitors the rates it intends to bid in advance of that bid.

Finally, requiring a service provider to obtain regulatory approval before submitting bids also wastes resources because the service provider may not win the contract. If a service provider's bid does not win, both the service provider and the regulator(s) that had to examine and approve the proposed rates will have wasted time and manpower in a process that ultimately was unnecessary.

It is perfectly reasonable to require service providers to establish rates and identify the relevant documentation before submitting bids if they are using Methods 1 or 2. But if they are using Method 3, this requirement will lead to administrative waste and unnecessary delays at best, and at worst will undermine the competitive bidding process by preventing service providers from submitting bids on time. TeleQuality thus asks the Bureau to clarify that service providers using Method 3 need not submit the rural rate for approval before filing bids, but rather before the rural HCP files an application for RHC funding.

## **II. The Bureau Should Clarify What Documentation Satisfies the “Publicly Available Rates” Requirement**

When service providers use Method 2 under the Commission's rules to determine their rural rates, they must use other carriers' tariffed or “other publicly available rates.”<sup>8</sup> Similarly, the RHC program requires applicants to identify this comparable urban rate for the services they are purchasing using a tariffed or “publicly-available rate.”<sup>9</sup> In the *Public Notice*, the Bureau noted that applicants must provide documentation with their applications substantiating the rural and urban rates.<sup>10</sup> TeleQuality respectfully asks that the Bureau clarify its explanation of what

qualifies as the “publicly available” documentation used to substantiate both the rural and urban rates.

Method 2 requires service providers to identify tariffed and other publicly available rates charged by other service providers for similar services.<sup>11</sup> The *Public Notice* explains that “[p]ublicly available rates include, but are not limited to, those posted on a rate card on a service provider’s website or accessible via a public database.”<sup>12</sup> As an example of a public database, the *Public Notice* describes the E-rate Open Data Platform, and “encourage[s] participants to use this tool to familiarize themselves with potential service options in their rural areas.”<sup>13</sup> The definition of “publicly available” was included in the *Public Notice* in the context of calculating the Method 2 rural rate, but the same phrase is used by the Commission in the urban rate rule as well. The Commission would presumably use the same definition for both rules.

Unfortunately, it appears to be extremely difficult to provide supporting documentation of publicly available rates that meet with USAC’s satisfaction, even using the resources the Bureau specifically identifies.<sup>14</sup> Just last week, USAC rejected TeleQuality’s attempt to document urban rates using the E-rate Open Data Platform.<sup>15</sup> In its rejection, USAC explained that “[t]hough this rate can be viewed on our website, this rate was privately negotiated and is a

contracted rate between the school(s) listed and their service provider. This rate is available for public inspection and viewing but is not available to the public, it is only available to the school listed.”<sup>16</sup> The purpose of providing documentation of urban rates is to identify rates that are available to urban HCPs. Those rates available to urban HCPs are then supposed to be the rates that rural HCPs pay, so they have access to the same telecommunications services at comparable rates to those purchased by their urban counterparts. It is unclear why USAC believes that urban HCPs would not be able to negotiate for a similar rate as those received by schools and libraries in an urban area or why those rates would not be available to other customers in those urban markets. The competitively bid rates in the E-rate database reflect the pre-discount, i.e., the total cost of the service. Further, the E-rate database provides a way for USAC to validate rates that are being charged in those urban areas.

TeleQuality submitted publicly available urban rates in a formal list from two service providers, Lumos and Nitel, explaining that although their rates were not posted on their web sites, they were readily available by calling the providers. TeleQuality provided the contact information for Lumos and Nitel so that USAC can validate the rates.<sup>17</sup> USAC rejected these as well, because the rates were not posted on the providers’ websites.<sup>18</sup> Today’s unregulated industry makes this requirement unworkable. Determining whether rates are “publicly available” by defining that they are listed on a service provider’s website misses the fact that in an unregulated environment, service providers would not want to provide a list of their rates, only to

have their competitors undercut their pricing. The *Public Notice*, which stated it was providing guidance for FY 2019, was the first time that the Commission announced that comparable urban rates had to be published on a website. USAC, therefore, should not require publicly available rates to be published on a website for FY 2018.

In short, TeleQuality tried to use these three different sources of publicly available rates to justify urban rates, and none of them passed USAC's scrutiny. TeleQuality has no reason to believe that USAC will be any more receptive with respect to rural rates without guidance from the Commission as requested in this clarification request.

The only sources USAC has not questioned are tariffs, even though the rules allow "tariffs and other publicly available" rates. There must be some publicly available rate outside of a tariff that HCPs and service providers should be allowed to use to satisfy the rule. Numerous carriers are providing services at these bandwidths in urban areas. However, most of those carriers have rescinded tariffs for Ethernet and similar higher broadband services, which comprise a large portion of the services TeleQuality delivers. This issue drives applicants and vendors to search for publicly available rates from applicable carriers more than ever before.

More generally, TeleQuality respectfully asks the Bureau to consider that tariffs do not necessarily reflect the realities of the marketplace. DS3s still appear in tariffs, for example, even though no customer would choose a DS3 over fiber where both were available because DS3s can be up to 10 times more expensive.

The rate identified for use as the urban rate can determine whether the rural HCP can afford the telecommunications service necessary to provide health care. In the Telecommunications Act of 1996, Congress mandated that the rates for services provided to rural HCPs be "reasonably comparable to rates charged for similar services in urban areas" in the

same state.<sup>19</sup> Urban rates do not satisfy the statutory requirement of reasonably comparable rates when they do not reflect market realities, and rural HCPs are paying significantly more than their urban HCP peers for the same bandwidth service.

For these reasons, it is extremely difficult for a service provider to satisfy the criteria of a publicly available rate for both Method 2 and urban rates. TeleQuality respectfully requests the Bureau clarify how service providers may meet the “publicly available rates” standard, keeping in mind the purpose of the RHC program—to ensure rural health care providers are paying a comparable price for telecommunications services as their urban counterparts. As evidenced by the fact that USAC accepted other forms of documentation until FY 2018,<sup>20</sup> the Commission has the authority to accept a wider variety of documentation that satisfies the statutory goal of the program, while still ensuring that USAC can validate its authenticity.
