Dear Ms. Dortch:

T-Mobile US, Inc. (“T-Mobile”) hereby submits a supplemental document production in and other materials in response to the Federal Communication Commission’s (“FCC’s”) Information Request of October 17, 2018.<sup>1</sup> The first DVD contains the load files and production associated with the document requests in the Information Request, containing items tagged as “Supplemental Highly Confidential,” “Highly Confidential,” “Confidential,” and “Public,” per the Protective Order and Supplemental Protective Order.<sup>2</sup> The second DVD contains addenda to the privilege log entries associated with the production, which has been classified as “Highly Confidential.”

Pursuant to the procedures set forth in the Protective Order and Supplemental Protective Order, a copy of the filing is being provided to the Secretary’s Office, including both DVDs. In addition, two copies of the Supplemental Highly Confidential Filing are being delivered to Kathy Harris, Wireless Telecommunications Bureau, with a copy of the DVD containing the addenda to the
