Dear Ms. Dortch,

I am the Assistant Superintendent for Business and Technology (Chief Financial Officer) for the City of St. Charles School District. I have held this position since July 2012. I am asking for a waiver of the rules regarding the e-rate program so that our district is not required to pay back fund to USAC.

USAC approved our request for funds for funding years 2013, 2014, 2015, and 2016. The same language which they have now determined to be a disqualifying error was used (erroneously) in each of these applications.

The City of St. Charles School District strives to be a good steward of public funds by conservatively budgeting our purchases. The e-rate program has provided necessary supplemental funds, which have helped the district to achieve a fair amount of equity in technology access for our students. Repayment of these funds would severely handicap the district in our efforts to provide students with the tools necessary for success in the 21st century.

Our district has a free/reduced lunch count percentage that has varied from 40-42% over the past five years. This is the highest rate in our county. We also have the highest mobility rate for student families. Additionally, we serve a population which has the highest rate of students with identified special needs (through the IEP process) of any district in our county; 16.9%. We also serve almost 300 students, over 6% of the population, who speak a language other than English as their native tongue. These factors lead to a larger than average percentage of students at-risk for failure and a lower than average contribution from parents through tax dollars.

I request that the FCC approve a waiver for our appeal of the USAC decision to deny our funding. To do so would allow the district to continue with implementation of a robust technology presence in all our schools for all students. If the district is denied this appeal, we will be forced to drastically curtail our technology purchases and support, which will have a direct impact on our students into the future.
